MINUTES

CALL TO ORDER

Chairman William "Bill" Landry called the Juvenile Justice & Delinquency Prevention Advisory Board meeting to Order at 9:02 a.m.

There being no further discussion, Chairman William "Bill" Landry asked for a motion to recommend approval of the above District 8 – State Level JJDP Applications. Mr. Roy Juncker, Jr. made a motion to recommend approval. Mr. Joshua Muller seconded the motion. The motion carried.

REPORTS

A. Federal Issues/Updates, Ms. Vi-Eve Martin-Kohrs (ViEve)

ViEve provided information to the board of the ongoing concerns of the Federal Advisory Committee on Juvenile Justice and the Reauthorization of the Juvenile Justice & Delinquency Act. ViEve commented that it had been 7-8 years since the last reauthorization was approved. The holdup of the reauthorization is an objection to the 'status offense language' being removed, Valid Court Order (VCO), 72-hour rule exception. ViEve said most recently, the committee she is a part of wrote a letter to Senator Klein, Chairman of the House Committee on Education and Workforce, and Senator Grassley, Chairman of the Senate Judiciary Committee, both who are advocating strongly that the Bill will be reauthorized. She will keep the board informed on the movement of the bill, and is hopeful for a positive outcome, soon.

B. Juvenile Justice Federal Programs, Mr. Demetrius Joubert

Mr. Joubert made the board aware that the revisions of the 3-year plan originally submitted in January, 2016 had been completed and re-submitted for approval. He mentioned that he would notify the board once the 2015 funds are approved. Also, the release of the 2016 funding is expect soon and solicitation will need to be written. Mr. Joubert welcomed any board members that would be willing to assist in writing the solicitation.

C. Governor's Conference (April 27th – April 29th, 2016) Ms. Dana Menard

Ms. Menard stated that conference preparations were going well; however, she was somewhat concerned about overall attendance, given shortfall of state funds availability for agencies to send people. At this time, there are 40 registered attendees, and there are still a number (6-7) of workshop timeslots needing to be filled with attendees. Ms. Menard asked the board members for any ideas that could be pursued to increase attendance. Some suggestions were,

- CEUs offerings. Ms. Menard responded there were 3 at this time.
- Other agencies that could be notified about the conference.
 - FINS (Families in Need Services)
 - LJDA (Louisiana Juvenile Detention Association)
 - Louisiana Children and Youth Planning Board Cabinet, Dr. James Gilmore, Director of the Governor's Children's Cabinet. Ask to forward to their contacts
 - DCFS Coordinated System of Care (Regional Wrap-around agencies)
- Various licensed professionals' agencies, such as social workers

Mr. Julio Galan gave kudo's to Ms. Menard about the content of the conference, the location, price, etc. He also mentioned that contact has been made with the Governor's Office to let them know about the conference. Mr. Galan expressed to the board that it was up to us to share with others about the conference to gain more attendance.

OTHER NEW BUSINESS

A. Resignations Announced

- Chairman, William "Bill" Landry informed the board, guests and LCLE staff that he would be stepping down as chair of the JJDP Advisory Board, given his new employment is fulltime. He expressed how much he has enjoyed being a part since 2009. During this time he said we have taken tremendous strides forward and it has been a great learning experience. He commented that he would continue serving in chair capacity until another chair was appointed by Governor John Bel Edwards. Various board members thanked him for his service.
- Mr. Roy Juncker, Jr. made the board aware the he would be stepping down and that this meeting (March 2, 2016) would be his last meeting.

Introduction of LCLE New Executive Director, Mr. Jim Craft

Chairman, William "Bill" Landry introduced and welcomed Mr. Jim Craft to the Louisiana Commission on Law Enforcement (LCLE). All in attendance welcomed Chief Craft with a loud handclap.

B. JDAI/DMC, Ms. Marjory Patterson

Ms. Patterson offered her availability after the advisory board meeting for any question the board may have for her regarding JDAI/DMC. In addition, Ms. Patterson asked if board members that participate on the committee for JDAI would let her know.

C. School Resource Officers' Trainings, Commander Bobby Robinson, Calcasieu Parish Sheriff's Office and Bob Wertz, LCLE, P.O.S.T. (Peace Officer Standards and Training Council) Section Manager After lengthy open floor discussion, the following outcome was determined, regarding CIT (Crisis Intervention Training) and SRO (School Resource Officers) trainings.

RECOMMENDATION BY THE BOARD:

Chairman Landry stated that the recommendation of the JJDP Advisory Board is for POST to encourage CIT training, although not a requirement in conjunction with SRO training. Dr. John Ryals, Jr. will draft a letter to the POST Council regarding CIT inclusion. Dr. Ryals will forward the letter to Chairman Landry, prior to being sent.

D. Dr. Mary Livers, OJJ Budget

Dr. Livers brought up several efforts to the board for discussion and recommendation.

National Concerns

Revising all ACA Standards to Juveniles
 There is discussion regarding revisions to detention standards, specifically – 'use of separation'.

Do our standards address isolation? It was stated that the isolation and separation should not be used as a form of punishment or consequence, according to federal standards. Dr. Liver's mentioned that we may need to revisit the Detention Standards to ensure uniformity is across the board. It was suggested that the JJDP Board contact the Detention Association and further address concerns.

• RTA (Raising the Age)

Dr. Livers wanted to apprise the board members the position of (OJJ) Office of Juvenile Justice. OJJ believes that raising the age of majority to 18 years old is the right thing to do.

The concerns:

- o Time-frame of implementation. We would like to see a 5-year implementation period.
- o New facility would likely be needed. The concern would be no funds available.

- Budget FY-16
 - o Deficit currently and for the past 3 years.
 - o 5.8m deficit if no supplemental is allocated.
 - o Possible furlough staff if there is no positive outcome FY-17.
 - o If revenues are not raised there will automatically be a 63% cut to include,
 - closure of one facility and decrease the capacity at the other facilities to place kids in secure care. There would be no money for non-secure care and probation and paroles offices will be closed. This obviously is a public safety concern. Direct services would be non-existent.

Dr. Livers ask the JJDP Board members to communicate that Office of Juvenile Justice should not be cut. She asked if the letter could be sent today (March 2, 2016), during the Regular Session.

RECOMMENDATIONS/MOTIONS:

- o Roy Juncker made a motion for a letter to be written, requesting all cuts be eliminated from Office of Juvenile Justice addressed to the following:
 - o Governor John Bel Edwards
 - Speaker of the House
 - Senate Finance Committee Chair
 - o President Pro Tem of Senate
 - o House Ways and Means and Appropriations Committee, and anyone else influential in this process that would cause devastation to the Office of Juvenile Justice.
