#### **REPORTS**

#### A. Federal Issues/Updates / Ms. ViEve Martin-Khors

No report. Ms. ViEve Martin-Kohrs mentioned that her term of serving was over, and no longer on the board. She commented that she was not certain if a new director has been appointed at this time.

#### B. Juvenile Justice Federal Programs / Mr. Demetrius Joubert

Mr. Demetrius Joubert reported that the 2018 Solicitation will be released in December 2017. Also, the hold on the funds have been released, so the 2017 applications will be able to go to the March or June 2018 meeting.

#### C. Disproportionate Minority Contact / Ms. Opal West and Ms. ViEve Martin-Khors

Opal reported that we are waiting to receive the Solicitation in order to apply for the 3-year Plan, in addition to submitting the 3-year DMC Compliance Plan.

#### Draft of Strategic Plan - Ms. ViEve Martin-Khors, Chair / Dr. Stephen Phillippi, Co-Chair

Opal advised that the Committee has been in contact via telephone, working on the **draft** of a Strategic Plan. ViEve mentioned that because it is still in a draft status, it's not being shared at this time.

#### Ms. ViEve Martin-Khors

A 1/2 day DMC strategic planning retreat is tentatively scheduled for January/February 2018. This retreat will be to discuss updates, policies and strategy moving forward. ViEve expressed that the greater goal would be to have a complete training (1-2 days) for the JJDP Advisory Board in general, given there are a number of new members. This training is independent of the Governor's Conference in April. \*Opal is working on logistics/times/dates.

#### Technical Assistance Request - Ms. ViEve Martin-Khors / Ms. Opal West

ViEve brought up that Opal has submitted a technical assistance request to OJJDP; however there may be another avenue for technical assistance, researchers, and legal technical experts. She further commented that there are several agencies that offer technical assistance. Opal commented that she has reached out to is CCLP (Center for Children's Law and Policy). The Center for Children's Law And Policy is an organization best known for their work to improve conditions of confinement in juvenile detention centers, eliminating solitary confinement, and eliminating racial and ethnic disparities. Their work has brought better outcomes for youth in confinement, as well as, policy development that has changed the treatment for youth in the system. She also has been in contact with an Independent Contractor, Mr. Lindsey Draper. There are other agencies that have knowledge of JDAI, but not the technical support aspect. Opal will apprise the board of updates.

#### D. Reports from JJDP Subcommittees

A verbal report was provided from a representative of each subcommittee.

Report handouts will be provided to JJDP Program Manager (Demetrius Joubert), prior to board meetings, and included in the Minutes. Handouts will also be retained in the permanent board meeting records.
