Raise the Age Implementation



Raise the Age (RTA)

- June 2016 SB 324 raised the age of juvenile court jurisdiction so that 17-year-olds will not be automatically treated as adults
- Two phases
 - 1. March 1, 2019 17-year-olds charged with non-violent offenses as defined in R.S. 14:2 will enter the juvenile justice system
 - 2. July 1, 2020 17-year-olds charged with crimes of violence will enter the system
- Important to know: This law only applies to 17-year-olds arrested and charged with nonviolent offenses on or after March 1, 2019 AND 17-year-olds arrested/charged with violent offenses on or after July 1, 2020

Raise the Age: Phase 1

- · March 1, 2019:
- Youth alleged to have committed nonviolent offenses at the age of 17 will be considered juveniles
- Youth alleged to have committed crimes of violence at age 17 will continue to be treated as adults.
- If a young person is charged with both a violent and non-violent offense, they can be treated as an adult for the violent charge (e.g., booked in the adult jail), but the non-violent offense should be processed as a juvenile charge.
- This law is **not** retroactive.

Why RTA?

- Children in the juvenile justice system are less likely to reoffend than those prosecuted as adults because only the juvenile system provides age-appropriate services to get kids on the right track.
- that involve neither violence nor a weapon.
- Youth in adult facilities face high rates of physical abuse and sexual assault, and are to commit suicide than children in juvenile facilities.

How to implement raise the age

- Address delinquency of 17-year-olds just like you have addressed delinquency of other minors
- Use detention as a last resort
- Exercise discretion to COUNSEL AND RELEASE 17-year-olds to the care of their parents with a written promise to appear in court when notified
 - Children's Code Art. 814

Louisiana Law Gives Law Enforcement Significant Discretion

Louisiana Children's Code Article 814

Discretion to not make an arrest:

Art. 814. Taking child into custody without a court order; duties of the officer; duties of the court

A. A child **may** be taken into custody without a court order or warrant by a peace officer or probation officer if the officer has probable cause to believe that the child has committed a delinquent act.

Discretion to release youth to parents:

Art. 814 (B) If a child is taken into custody without a court order or warrant, the officer shall have the responsibility to **either**:

- (1) Counsel and release the child to the care of his parents upon their written promise to bring the child to court at such time as may be fixed by the court.
- (2) Promptly escort the child to the appropriate facility in accordance with Article 815.

Opportunity for police diversion

Opportunity to avoid detention

Consider Counsel and Release for:

- 1. Criminal mischief
- 2. Criminal trespass
- 3. Disturbing the peace
- 4. Minor traffic violations
- 5. Misdemeanor illegal possession of stolen things
- 6. Misdemeanor obstruction of justice

- 7. Misdemeanor theft/theft of goods
- 8. Obstructing public passages
- 9. Simple assault
- 10.Simple battery
- 11.Simple possession of marijuana
- 12.Simple burglary

Other strategies to ensure effective implementation:

- Reduce the use of pre-trial detention (Detention Screening)
- Develop and Increase the use of Alternatives to Detention
- Make probation and aftercare approaches more effective
- Address young people's mental health needs outside of the juvenile justice system
- Reduce reliance on facilities and focus resources on community based approaches/resources
- · Expand the use of diversion
- Keep young people safe by complying with the Prison Rape Elimination Act (PREA)
- Improve Juvenile Justice Systems'
 management of resources and strengthen
 strategies to serve young people more
 effectively

Raise the Age Reference Card

Under the Raise the Age Louisiana Act people younger than 18 years old are children who are subject to juvenile justice system and procedures starting on March 1, 2019. However, some 17-year-olds will continue to be considered adults, 17-year-olds who are charged with crimes of violence (see back of this card) will remain subject to the adult criminal justice system procedures until July 1, 2020.

This card will expire on 6/30/2020

Raise the Age Referral Card

When an officer stops a child on suspicion of committing a delinquent offense without a warrant or court order, the officer has discretion to NOT transport the child to a detention center.

The officer can COUNSEL AND RELEASE the child to the care of his/her parents with a written promise to appear in court when notified, (La. Ch. Code Art. 814)
