Dr. Phillippi inquired about the attributing factors to such a high success rate with the new SRO, School Resource Officer. He wanted to know if his success was attributed to skills, personality, personal charisma, all of the above or something else. Chief Wooley, the rep., noted that she felt it was a combination of all the above. The SRO is the first person to interact with the kids. He is youthful and very skilled as he continues to take classes on domestic violence and sexual assault. Mr. Johnson asked if there was some kind of formal interview done to see if the child and the SRO were compatible. Chief Wooley stated that no, there is not, but that the SRO is probably one of the first positive experiences with an officer that many of these students have had. The town is small which makes him familiar with the kids as he works with them personally every day and on a long-term basis. He works with the kids mental and physical barriers and because of his effort they have seen a decrease in fights by 15%. Dr. Phillippi recommended that maybe the SRO could speak at the Governor's Conference.

Ms. Martin-Kohrs called for a motion to approve the above listed District 1 JJDP Applications with the above mentioned recommendations. There was a motion made by Mr. Johnson, seconded by Ms. Daly. There were no objections; the motion passed.

Ms. Daly questioned why the program started with second grade instead of kindergarten. The representative, Ms. Lafleur, answered that the data collected from the courts and the officers indicated that there was a need in the area of second through fourth grade for truancy. Ms. Daly stated that the data presented was not really measurable to see an outcome of kids in school and less truancy and that she would like to see some form of measurable outcomes added to the application. Mr. Johnson asked if a data collection process accountant monitors the programs efficiency. Ms. Lafleur mentioned that they are currently partnered with the school board and the school board does not measure these cases in totality but instead on a case referred and accepted bases. It is also mentioned that they can start measuring these cases on their own on a quarterly basis. Ms. Daly also recommended for the families to be placed on plans and that some type of partnership with community services be obtained. Ms. Lafleur mentioned that the local Community Cares Organization is already branched out into so many services geared more towards mental health facilities for adolescents. There are not many community services available but the program will reach out to explore what else might be available to the parents and kids needs in an effort to decrease the truancy cases.

Ms. Martin-Kohrs called for a motion to approve the above listed District 3 JJDP Applications with the above mentioned recommendations. There was a motion made by Dr. Phillippi, seconded by Mr. Tramble. There were no objections; the motion passed.

Dr. Phillippi questioned if the Trauma Cognitive Behavior Therapist was certified. The representative, Ms. Young, answered that yes, they are. Dr. Phillippi inquired about the outcomes and why there was only a 70% completion rate of the program. Ms. Young stated that it is very difficult for these kids to finish the program due to a lack of communication from the parents and them just dropping off. Another problem is that a lot of the human trafficking kids run away. Also, it is a very rural area and if they are sent to a detention center it is not a detention center in the 16th Judicial District because they do not have one. They are being sent all over the state which makes it hard to track them. Dr. Phillippi asked how these outcomes were measured. Ms. Young mentioned that there is a beginning, middle, and end assessment between the therapist and the parents discussing behavior improvements or impediments. Dr. Phillippi suggests that he would like to see more improvement in the marked behavior details in this project. Ms. Young acknowledges this request and also notes that the therapist has been trying to get more involved with the court system to try and demand therapy so that the adults are held accountable for keeping their children in the program from the beginning to the end.

Ms. Martin-Kohrs called for a motion to approve the above listed District 4 JJDP Applications with the above mentioned recommendations. There was a motion made by Dr. Phillippi, seconded by Mr. Johnson. There were no objections; the motion passed.

Ms. Jackson asked if Terrebonne was seeing a lot of sexual offender situations between the staff and the juveniles. The representative, Mr. Harris, answered that no, they had not, but there had been some cases in the parish. Mr. Harris stated that because of this, they wanted to take the opportunity to educate the staff and the juveniles on those kinds of situations. Ms. Jackson questioned if they already had cameras on the premises and if they were using these funds to try and get more. She also inquired on how the cameras are being maintained. Mr. Harris stated that they already had cameras and that they were trying to get more to cover the areas of the facility that were high-trafficked areas and not already being covered. He mentioned that the funds would be used to update some of the old cameras as well as purchase some of the new ones.
