38th Governor's Conference Report (2018)

Dana Menard, Chair

The 38th Governor's Conference on Juvenile Justice was held April 18-20, 2018 at the Baton Rouge Marriott in Baton Rouge. There were 440 pre-registered participants upon arrival and the usual "no shows" and on-site registrations. These numbers were higher than in recent years.

We partnered again this year with Families in Need of Services (FINS). They sponsored 13 workshops, the opening keynote speaker, held their annual meeting, provided the morning break, brought door prizes and held a networking reception on the first night of the conference. Once again, we had three sponsors for the conference, the Louisiana Sheriff's Association, Louisiana District Attorney's Association and the Louisiana Council of Juvenile and Family Court Judges. There were four exhibitors on site as well.

A review of the overall evaluations indicated: diverse workshops, topics relevant to the issues at hand, knowledgeable presenters, excellent learning experience, the number of and scheduling of workshop topics, diverse participants, organization, networking and both the opening and closing speakers. Improvements needed included: length of some classes (some requesting shorter and some longer sessions), obtaining CEU information earlier, tables in the rooms (we cannot fit tables in some salons but did have them in others), handouts handouts handouts, payment by credit card. The most noted trainers were Steve Perry, Tommy Karam, Joe Wegmann, and Leroy Crawford.

OJJ provided us with the Junior Chefs again this year and are always a highlight of the conference. The pastries were delicious and the young men were very respectful and well-behaved. The choir was in attendance for the opening and were also noted as a highlight of the conference. The annual auction was successful and I think all items were sold.

We were able to provide 12.75 hours of credits for Licensed Professional Counselors, up to 13 hours for Social Workers and 9.75 hours of Continuing Legal Education for participants. Participants that submitted an attendance sheet were issued certificates as requested. CLE units were submitted on line to MCLE. FINS handled the LPC hours.

Thanks to all LCLE staff and J-Board members that assisted with registration, putting the packets together, folding t-shirts, hauling boxes, moderating workshops, bringing door prizes and providing training to the participants on relevant topics.

- 5. Developing a Listserv for DMC-related communications
- 6. Publish a newsletter
- 7. Develop unified DMC talking points
- 8. Explore the possibility of the both committees combining initiatives (JDAI State Scale and Governor J-Board).

The DMC Committee invites further input and suggestions are we move the state forward in DMC reduction initiatives.
