COMMITTEE REPORT

MARCH 14, 2018

The DMC committee chair and Co-chair met on March 9, 2018 with Opal West, State DMC Coordinator, to discuss updates from the past and present DMC initiatives and next steps for the DMC committee.

The OJJDP 2018 Solicitation is out and Opal will be submitting a Louisiana DMC plan update to OJJDP by the deadline.

The committee discussed the current Annie E. Casey's statewide Juvenile Detention Alternatives Initiative (JDAI). The state-wide workgroup is actively working towards DMC reduction strategies in the 5 core sites.

The OJJDP Technical Assistance request has been approved by OJJDP and consultants have been appointed. The training with the entire board will be held on either Monday, May 14th or Tuesday, May 15th. A follow-up announcement will be made as to which day the board will meet for training. The additional day will be reserved for TA for Opal and any other selected partners as needed.
