CALL TO ORDER

Chair William Landry called the meeting to order.

ROLL CALL

Roll call was taken. A quorum was present.

ADOPTION OF THE AGENDA

Chairman William "Bill" Landry asked for a motion to adopt the agenda with the amendment. Curtis Hooks made the motion. Dana Menard seconded the motion. The motion passed without opposition or abstention.

Chairman William "Bill" Landry announced the requirements to attend Board and Commission meetings.

OLD BUSINESS

A. CONSIDERATION OF MINUTES

Chairman William "Bill" Landry asked for a motion to accept the November 14, 2012 meeting minutes. Curtis Hooks made the motion to accept. Dana Menard seconded the motion. The motion passed without opposition or abstention.

B. OLD BUSINESS

- 1. **DMC Non-Compliance** Katherine Guidry advised the Board members that a waiver on the DMC non-compliance was submitted to OJJDP. As of date, the office had not received any word from OJJDP.
- 2. **Egrants System** Katherine Guidry provided an update on the Egrants transition. Effective with the May meetings, agencies will be submitted their application on-line. The next steps will include the development of a user manual and providing regional trainings in June or July.

NEW BUSINESS

A. Allocations

A total of four FY 2012 Title II Formula Grant Program allocations totaling \$40,786 were presented for consideration.

District 2 presented two allocations (1 new and 1 continuation) for a total of \$20,552. Roy Juncker, Jr. made the motion to recommend approval. Ronald Rossitto seconded the motion. The motion passed without opposition or abstention.

District 6 presented two allocations (1 new and 1 continuation) for a total of \$20,234. Tyler Lax made the motion to recommend approval. Claire Daly seconded the motion. The motion passed without opposition or abstention.

With no additional discussion, Roy Juncker, Jr. made the motion to recommend approval. Ronald Rossitto seconded the motion. The motion passed without opposition or abstention.

2. J10-8-002, Louisiana Commission on Law Enforcement, "Compliance Monitor", Existing Federal Amount \$50,000; Proposed Increase \$89; Revised Federal Award \$50,089; Representative: Katherine Guidry

With no additional discussion, Dr. John Ryals, Jr. made the motion to recommend approval. Ted Cox seconded the motion. The motion passed without opposition or abstention.

Juvenile Accountability Block Grant Program

Crystal Foster presented 18 applications.

With no additional discussion, Ronald Rossitto made the motion to recommend approval. Ted Cox seconded the motion. The motion passed without opposition or abstention.

2. Egrants – 4th Judicial District Attorney's Office, "Home Detention", \$15,000 (continuation); Representative: Vera Davis

The applicant agreed to the Board's request to adjust the application to include good behaviors and assessment tools and to provide a copy of the assessment to the staff. With no additional discussion, Tyler Tullos made the motion to recommend approval. Ted Cox seconded the motion. The motion passed without opposition or abstention.

3. Egrants – 13th Judicial District Attorney's Office, "Court Diversion", 15,000 (continuation); Representative: Julhelene Jackson

The applicant agreed to the Board's request to provide additional information outlining duties of personnel. With no additional discussion, Curtis Hooks made the motion to recommend approval. Tyler Tullos seconded the motion. The motion passed without opposition or abstention.

10. Egrants – Caddo Parish Commission, "Supervision and Probation", \$17,000 (continuation); Representative: Ted Cox

With no additional discussion, Roy Juncker, Jr. made the motion to recommend approval. Dr. John Ryals, Jr. seconded the motion. The motion passed without opposition. Ted Cox abstained.

11. Egrants – Calcasieu Parish Police Jury, "Juvenile Assessment Center", \$15,000 (continuation); Representative: Vi-Eve Martin-Kohrs

With no additional discussion, Tyler Lax made the motion to recommend approval. Claire Daly seconded the motion. The motion passed without opposition. ViEve Martin-Kohrs abstained.

12. Egrants – Hammond, City of "*Probation Counseling*", \$15,000 (continuation); Representative: Reginald Sanders

The applicant agreed to the Board's request to adjust the application to correct the number of targeted kids and track the recidivism rate. With no additional discussion, Roy Juncker, Jr. made the motion to recommend approval. David Zoller seconded the motion. The motion passed without opposition. Dr. John Ryals, Jr. abstained.

 Egrants – Iberia Parish Sheriff's Office, "Supervision and Probation", \$15,000 (continuation); Representative: <u>Sole Source Request</u>

Due to non-representation, David Zoller made the motion to recommend table the application to the May meetings. Dr. John Ryals, Jr. seconded the motion. The motion passed without opposition or abstention.

14. Egrants – Louisiana Office of Juvenile Justice, "Job Readiness / Skill Retention", \$80,000 (continuation); Representative: Kim Mims, James Green, and Paul Graham

The applicant agreed to the Board's request to track the juveniles within the purview of the law through the use of consent forms to see if youth are employed. With no additional discussion, Roy Juncker, Jr. made the motion to recommend approval. Ted Cox seconded the motion. The motion passed without opposition. Karen Stubbs abstained.

15. Egrants – Natchitoches Parish Sheriff's Office, "Teen Court", \$15,000 (continuation); Representative: Kathy Davenport-Clark

With no additional discussion, Roy Juncker, Jr. made the motion to recommend approval. Tyler Tullos seconded the motion. The motion passed without opposition or abstention.

Egrants Orleans Parish District Attorney's Office, "Records Management", \$21,880 (continuation); Representative: Ralph Brandt With no additional discussion, Dr. John Ryals, Jr. made the motion to recommend approval. Ronald Rossitto seconded the motion. The motion passed without opposition or abstention.
- 17. Egrants Plaquemine, City of, "Probation Counseling", \$15,000 (new); Representative: Mervin J. Gourgues

The applicant agreed to the Board's request to adjust the application to expand on the services, the number of youth to be served, expedite of cases that both the prosecution and public defender will provide. The Board stated that based on the application's activities, the current project title should be changed to "Court Staffing." With no additional discussion, David Zoller made the motion to recommend approval. Claire Daly seconded the motion. The motion passed without opposition or abstention.

18. Egrants – Rapides Parish Police Jury, "Assessment Center", \$15,000 (continuation); Representative: Larry Spottsville

The applicant agreed to the Board's request to use a valid risks and needs assessment tool to identify the criminology. With no additional discussion, Roy Juncker, Jr. made the motion to recommend approval. Alberto Galan seconded the motion. The motion passed without opposition or abstention.
