Master Plan Introduction

Dr. Ed Bee reviewed the methodology and initial findings of the LaBIC Statewide Master Plan. Dr. Bee reviewed the working groups' priorities, the trends in international trade/port activities, FDI trends and standings. Louisiana ranks very high in both as indicated by Dr. Bee's findings. Dr. Bee led discussions on how COVID impacted trade, near/friend-shoring and shifting volumes of trade/FDI with China and

other countries. He presented the timeline and next steps to facilitate adoption/approval of the master plan. Board members were able to ask questions and make additional suggestions for inclusion in the "final" version.
