Commission advised to purchase necessary licenses and event requests online.

Casey McKenzie – Titan Combat – discussed event at L’Auberge Casino and issues with not knowing the layout of the venue. Discussed issue of D.P. approaching him during the event to discuss Commission seats. Commission reiterated the importance of Commission seating during events. Commission also reiterated that 24 hours prior to an event promoter will be notified regarding unneeded and available commission seats to sell to event attendees. – \$1,500 fine imposed

Jose Llanito – wanted to discuss a personal issue with another promoter and requested the commission to begin an investigation against a ring announcer for what he believes he is trying to sabotage or bring Mr. Llanito’s manager’s license into question. Commission advised

that if the issue is not directly related to an event, it does not have the ability to get involved in personal and/or legal issues occurring behind closed doors.
