2) MINUTES AND FINANCIAL REPORT:

C.D. explains incident during a fight where the doctor enters the cage, referee stops the fight. C.D. adding to pre-fighting instructions doctor must wait for referee to stop fight before entering the ring.

J.G. motions to approve requested shows, D.P. seconds, all vote in favor.

7) **NEW BUSINESS:** C.D. presents Cooper Housely’s fight decision appeal due to an illegal hit, Kaleo Kanekoa with a similar complaint and Hunter James due to low blows and point deduction. J.G. reiterates the Commission is not legally allowed to overturn a judging or referee decision unless fraud was involved. C.D. states he informed all complainants of the ability to attend this meeting, however; no guests are present. Consensus of the Commission is to uphold the current statute. A.G. motions to deny Cooper Housley’s appeal, R.N. seconds, all vote in favor of the motion. A.G. motions to deny Kaleo Kanekoa’s appeal, R.N. seconds, all vote in favor of the motion. A.G. also motions to deny Hunter James’ appeals, R.N. seconds, all vote in favor of the motion.

R.N. Presents another appeal request from Josh Quayhagen received the evening. Due to the timing of receipt of the complaint, it will be reviewed during Commission meeting in September.

J.B. presents the public records request received via e-mail from Asher Vogt for judge's scorecards from May 10, 2002 – June 6, 2012. Commission discusses current method of maintaining records. Statute requires five years retention of records; thus, the requested records are no longer available.

Llanito brothers are currently advertising a show for October 18, 2025 in Shreveport on social media. J.G. expresses it is illegal to advertise a show without a license.

Discussion on steps to take to change name on bank accounts with J.G. and J.B. to work together to obtain correct classification from the bank.

Discussion regarding rules on Muay Thai, kickboxing and no-takedown MMA. R.N. to obtain rules from Larry Maxwell.

- 8) **OLD BUSINESS:** M.H. updated the Commission with the contact information for someone to promulgate rules. Her contact information was passed on J.G. R.N. motions to grant J.G. permission to hire an individual at the state allowed pay rate to promulgate the rules, D.P. seconds, all vote in favor.
