2) MINUTES AND FINANCIAL REPORT:

September minutes as well as financial statement, monthly bills and salaries presented including breakdown of expenses and monthly income received for the month of October. J.S. motions to approve, D.P. seconds, all vote in favor.

Grant presents to the meeting to discuss the complaint of a low hit during a fight. J.G. discusses the video of the incident with Mr. Grant which the Commission as reviewed. It was determined cocaine was not taken day of the event but the Anti-Doping Group recommended a 6 -month suspension. Powerslap has agreed to both recommendations.

D.P. motions to approve the recommendations from the Anti-Doping Group and to suspend both Mr. Godfrey and Mr. Kenakoa. W.G. seconds, all vote in favor.
