D.P. motions to approve requested shows, W.G. seconds, all vote in favor.

- 7) **NEW BUSINESS:** Ray Waters appealing due to doctor interference during the fight. Mr. Water's is asking fight be ruled as no contest. J.G. argues the Commission does not have the authority to change the outcome of a fight. C.D., W.G., D.P. and R.R. disagree and believe the Commission should have the right to overturn a fight outcome in special circumstances, such as this one as the result of this fight was directly impacted following the doctor entering the ring. J.G. expresses concern in the Commission allowing this fight to be ruled a no contest opens the door for others to appeal fight decisions. C.D, W.G and R.R. again argue this particular fight warrants a hearing due to the circumstances. Commission agrees to notify both parties of a hearing set for next month's meeting via certified mail by J.G.

C.D. discusses a reporter reached out to him regarding Power Slap and rumors somebody failed two drug tests. C.D. spoke with UFC and reiterated that event results are available to the public and drug testing is protected by HIPPA. Commission agrees with UFC's stance on the matter and agree any requests for medical information should be sent directly to UFC.

J.G. received a complaint from Josh Quayhagen regarding the August 28th fight in which he claims illegal blows to the back of the head and grabbing the fence when changing position. A video of the fight was also provided. J.G. again argues the

Commission does not have the authority to overturn a referee's decision and in this situation, the referee made a decision based on what was seen at the time of the fight. Commission agrees this particular situation does not warrant an over turn of the referee's decision. J.G. motions to deny Mr. Quahagen's request to, D.P. seconds, all vote in favor.
