2) MINUTES AND FINANCIAL REPORT:

4) LICENSE RENEWALS/APPLICATIONS:

Online application for contestant license working well. Discussed efficiency of online vs. paper licenses. Issues with some promoters preferring checks over credit cards due to paper trails and credit limits.

5) PAST SHOWS: Delta and recent boxing events were successful. Concerns raised about referee performance and crowd influence. Discussed handling passive fights and referee authority.

Discussion on Class B show credits or refunds based on CPA's suggestion. Preference for refunds to avoid tracking issues. Estimated refund is approximately \$2,000.00. Decision made to write a check and submit a letter to recipient to avoid potential issues. T.S. responsible for gathering necessary numbers and creating refund list from March 2024 to July 2024. J.B. to decide on the refund payment method. Only class B shows that paid \$250.00 are eligible for refund. Since July 1st there have been nine Class B shows that have paid \$250.00. Class A shows are not eligible for refunds.

Motion to send refunds was approved unanimously.
