Board of Regents' Chairman, Mr. W. Clinton Rasberry, opened the meeting by expressing his appreciation for those that had to rearrange their schedule to attend today's meeting. He also stated that the goal of the meeting was to review and approve the WISE Operational Policy and the Updated Distribution Model. He further stated that he was extremely pleased by the work that has been done; and there has been significant progress made since the last WISE Council meeting thanks to the contributions of all staff involved and the on-going work group meetings.

Approval of the minutes of September 8, 2014

On motion of Member King Alexander, seconded by Member Sandra Woodley, the WISE Council voted unanimously to approve the minutes of September 8, 2014.

Ms. Barbara Goodson, Deputy Commissioner for Finance and Administration gave a brief report on the review and approval of recommended operational policy. She added that the data group reconfigured the model to satisfy concerns regarding the earmarks.

Recommendation of Updated Distribution Model

On motion of Member Sandra Woodley, seconded by Member King Alexander, the WISE Council voted unanimously to approve the updated distribution model.

Mr. Raspberry noted that it is important that Council is available as needed to review and approve the necessary plans. He also asked everyone to please be sensitive to their schedule because timing will be very important to those programs that were previously mentioned. He added that all stakeholders are be present for the next WISE Council meeting, but it will be understood if someone can't be in attendance. He also stated that the items approved today will be presented at the September 25, 2014 Board of Regents Board Meeting and congratulated everyone personally.
