- a. Chief Tommy Clark, HTPC Chair, welcomed everyone and thanked everyone for joining the meeting.
- b. Dr. Dana Hunter introduced First Lady Donna Edwards.
  - i. First Lady Donna Edwards thanked everyone in attendance for their continued work in preventing Human Trafficking. First Lady Edwards is looking forward to what can be accomplished in the upcoming year. In addition, she brought up the following:
    - a. January is Human Trafficking Awareness Month
    - b. A need to increase education and training
    - c. Need for a public awareness campaign to be launched that is easily understood
    - d. Upcoming Global Summit where best practices across the states and globally can be shared
    - e. The Governor and First Lady will work with the new Presidential Administration especially in terms of Human Trafficking
    - f. Will continue to look for new opportunities to share information.
- c. Chief Tommy Clark stated that the Louisiana Human Trafficking Prevention Commission & Advisory Board(s) fully support the First Lady's Global Summit.

VIII. New Business: 2021 Legislative Priorities

- a. Presentations (approx. 5 minutes each)
  - i. Secretary Walters
    - Act 409 serves to create a statewide office of Human Trafficking in the Governor's Office. This would include a full time director with two other positions. The Human Trafficking director will be located in the Programs and Planning section of the Governor's Office and will oversee grants management as well as monitor and evaluate statewide efforts.
  - ii. Casey Morace and Michelle Johnson
    - Casey Morace met with stakeholders to discuss the Equality Model. She found that there were few discrepancies and most of the information provided was agreed upon by all parties.
    - Michelle Johnson reported on upcoming proposed legislation in regards to Criminal Justice Reform, including regional Task Force being created for victims of Human Trafficking to assure that cases are being properly investigated. Discussion followed.
- b. Discussion
  - i. Casey Morace stated that often in cases in small rural areas there can be a conflict of interest. In these cases it is important that law agencies from other areas are called in to investigate.
  - ii. There was discussion that there should be a special Human Trafficking Special Division Court that prosecutes only cases of Human Trafficking.
  - iii. In Shreveport there is a mandatory 'Buyer Beware Program' for those who have been arrested on charges of soliciting a prostitute and it was stated that this should be a statewide program.
  - iv. Need special prosecutors that work with Human Trafficking victims that treat them as a victim and not as a criminal
  - v. Mandatory training for criminal justice personnel from patrol officers to Judges
  - vi. Victims can have other charges brought against them besides just prostitution
  - vii. Revise statute of limitations for civil actions against hotels
  - Trafficking of persons with intellectual disabilities, the trafficker should be viii. prosecuted as if the victim was a minor
  - ix. Have all prosecutors fully training regarding Human Trafficking
  - x. Michelle Johnson and Alliece Cole are available to train law enforcement officers upon request

- Chief Tommy Clark requested that all members join one of the four sub-committees. a. Casey Morace supplied a link to a google form that allows each Commission/Advisory Board Member to select a sub-committee;
