Executive Director's Report

- ON MOTION OF <u>Kressy Krennerich</u>, SECONDED BY <u>Shawn McManus</u>, AND CARRIED, the Board voted to approve Budget Amendment for the Board of Tax Appeals Cooperative Endeavor Agreement for \$121,500 for 2021.
- <u>Information Only:</u> Mr. Kline discussed the research and use of the physical / municipal addresses of Post Office locations for P.O. Boxes.
- <u>Information Only:</u> Mr. Mekdessie provided an update on optional exemptions. Requesting collectors to go the Sales Tax Portal look up optional exemptions and rates for their jurisdictions.

• Information Only: Mr. Kolb provided an update on:

House Bill 562:

- 1. Restructures the secondary funding for the Board of Tax Appeals. If 47:302(K) distributions are insufficient, the BTA would go to the Remote Seller's Commission first and then to the LULSTB.
- 2. Changes part of the statute on funding provision and adds a reference to the funding agreements with local collectors to the LULSTB.
- 3. Requires an update to the board's strategic plan not less than once every five (5) fiscal years.
- Grant the LULSTB authority to go into Executive Session to discuss policy advice, private letter rulings, or other matters that may involve confidential taxpayer information.
- 5. Include the LULSTB as one of the entities whose records are confidential under LA RS 47:1508.

The Cooperative Endeavor Agreement for Board of Tax Appeals e-fling system the agreement was finalized with the LDR and BTA. Copies were provided for the LULSTB Executive Director's signature. The board's first payment of \$121,500 will be due 30 days from the date of execution of the agreement.

 Consider alternative meeting schedule for LULSTB members who also serve on the Remote Sellers Commission. To lessen the burden on those members where there may be challenges in the timing due to one body meeting virtually and the other in person, the LULSTB will allow members to access the RSC meetings via Zoom at the LULSTB headquarters.

Regulation Promulgation Update

- O Held scheduled final hearing to receive public comments on Audit Protocols this morning. No one attended via Zoom. After a brief discussion and recap, the hearing was adjourned without accepting any further comments. Mr. Kline will file his final report with the Legislative Oversight Committees and unless there are any objections or concerns, the effective date of the promulgation will be July 20, 2021.
- On the two refund claim regulations, LULSTB did receive non-binding comments from the LATA after the Notice of Intent had been submitted. Those comments will be treated as received during the public comment period. The public comment period will end on June 21, 2021 and a hearing is scheduled for June 25, 2021. All comments received will be evaluated including those received from the LATA to determine if any suggestions are considered substantive changes. If the changes are substantive, the process will start over again.
