Adoption of the Agenda

Remote Seller Commission Update – Renee Roberie, Executive Director

Renee Roberie, Executive Director of the Louisiana Remote Sellers Commission, provided an update on monthly collections and distributions for October 2021. See attached reports.

Board Member Requests

- API Fee for Service Contracts Chairman Ruppert
 - This is for the Board Look Up Tool and how to handle granting access to the private sector and also collectors, contract audit firms and other governmental agencies.
 - Chairman Ruppert asked LULSTB Board Attorney, Andrew Kolb to research the issue and to develop contracts for each of those possible scenarios where the board's look up tool could be used by others.
 - Mr. Kolb described three categories or "buckets" of entities:
 - Local Collectors and their contract auditors
 - Taxpayer / Dealers through an API connection
 - Other Governmental Entities such as the LA Department of Revenue and the Remote Sellers Commission.
 - Mr. Kolb has been drafting agreements for each of those categories to memorialize access to the application.
 - There's no fee to the Local Collectors for access to the bulk look up for those Parishes contributing to the board funding.
 - Third party agents such as contract auditors, there would be a separate agreement that references their agreement with the Local Collectors.
 - Taxpayer / Dealers through the API connection, a similar agreement would be drafted discussing use of the data and access to the app for purposes of compliance with local sales and use tax requirements.
 - Other Governmental Entities (LDR, RSC) would have Cooperative Endeavor Agreements (CEAs).
