She also recognized the continued partnership and collaboration among all the Historically Black Colleges and Universities (HBCUs) in Louisiana.

Each student received a certificate presented by their campus President or Chancellor. Dr. Reed invited HBCU Scholar Crystal Ammons to share highlights of her award-winning presentation provided to the MUREP Innovation and Technology Transfer Idea Competition, sponsored by NASA. The Commissioner and the Council commended the Scholars on their recognition and expressed their gratitude for their hard work.

#### NATIONAL BOARD OF ADVISORS ON HBCUS UPDATE

Commissioner Reed invited Dr. Walter Kimbrough, member of the President's National Advisory Board on HBCUs, to provide a federal update. Dr. Kimbrough thanked the Commissioner and the Council for extending an invitation to present. He shared informative updates on federal initiatives and areas of concern to HBCUs. He also provided a book of

interest to each Council member titled "Vital and Valuable: The Relevance of HBCUs to American Life and Education" written by James V. Koch and Omari H. Swinton.

#### HBCU WEEK RECAP

Dr. Reed invited Chancellor Pierre to provide a recap of 2023 National HBCU Week Conference. Chancellor Pierre shared information on behalf of the National Science Foundation, specifically regarding national investments in STEM education and funding opportunities to support research and broaden participation in artificial intelligence research, education, and workforce development. Chancellor Pierre proposed inviting Dr. James Moore, Assistant Director of STEM Education for the National Science Foundation, to present at the next Advisory Council meeting.

#### CYBERSECURITY UPDATES

Mr. Lonnie Leger, Executive Director of Louisiana Optical Network Infrastructure (LONI), presented information about the LONI Network and provided statewide cybersecurity updates.

Mr. Theodore Callier, Vice President of Research and Sponsored Programs at Grambling State University, provided information on cybersecurity programs and initiatives taking place at Grambling. He shared that Grambling has experienced an increase in enrollment in its Cybersecurity programs. Additionally, Grambling has partnered with Caddo Parish to launch a pilot program that aims to engage with local students to introduce them to careers in cybersecurity.

#### AFFIRMATIVE ACTION DISCUSSION

President Dennis Shields led a discussion about the Supreme Court's decision in *Fair Admissions, Inc. v. President and Fellows of Harvard College* and *SFFA v. University of North Carolina*.
