Meeting Notes:

- Introductions among participants were facilitated by Dr. Susan Nelson, who emphasized the importance of
 collaboration within the palliative care community. Key attendees included Dr. Alexandra Leigh from the VA,
 nurse practitioner Cinnamon Tucker DNP, and family advocate Dr. Trey Gibson, who shared personal caregiving
 experiences. The group collectively acknowledged the significance of support and teamwork in enhancing
 palliative care services.
- The discussion focused on the current state and future direction of palliative care in Louisiana, addressing resource gaps and opportunities for improvement.
 - Dr. D. Barfield highlighted the need for additional resources not currently available within the network, prompting Trey Gibson to suggest Hogs for the Cause, an organization that provides financial assistance to families with children facing serious illnesses.
 - Dr. Susan Nelson provided an overview of the committee's status, noting vacancies due to resignations and the potential for new appointments by Governor Jeff Landry or relevant organizations. Christine Guidry, RN, and Dr. Potash has resigned as has Dr. Corey Morrison (recommending Dr. Ashley Autreypediatric palliative care at Manning Childrens)
 - The meeting also addressed logistical considerations, with Dr. Susan Nelson proposing a shift to lunchtime meetings, which received positive feedback from several participants, including Dr. Trey Gibson and Debra Merritt. Dr. Sonia Malhotra raised concerns about scheduling conflicts for academic members but agreed that a post-noon time could work. Ricky Mannino RPh contributed insights from his extensive experience in hospice care, while Dr. Susan Nelson discussed legislative efforts, including a pilot project aimed at improving telehealth regulations for controlled substances.
 - Additional discussion involved caring for patients and families with serious illness in the face of immigration issues. Resources to be provided to attendees by members or their institutions.

• Guest Speaker:

Stacie Sinclair, Associate Director, Policy and Care Transformation with CACP presented a comprehensive analysis of Louisiana's palliative care landscape, introducing the new Serious Illness scorecard that aims to provide a more accurate assessment of palliative care access. She noted Louisiana's score of 2 out of 5 stars, highlighting strengths such as the presence of palliative care programs in large hospitals, but also pointing out the low number of certified professionals per capita. Sinclair emphasized the need for improved tracking of community-based palliative care services and encouraged attendees to ensure their programs are listed on the getpalliativecare.org directory to enhance visibility and support for patients and families.
