Ms. Flynn appointed Ms. Vallien to serve on the Policy Task Force to begin aiding staff with the updating of district policies.

Agenda VIII

Dr. Bell motioned to grant authority to the Personnel Committee to develop a search criteria process and guidelines to be developed within the next thirty days to be available for public comment in order to begin the superintendent search and selection process. The motion was seconded by Mr. Morris and all approved without objection.

Mr. Morris reviewed the Louisiana Department of Education's job description of the superintendent for the SSD, stating that it could be updated. He stated that the board would follow Revised Statute 17:54 as it relates to posting the job. The Personnel Committee will define the process for interview questions, submitting applications and public input in the process. The selection will be narrowed down to three candidates to be interviewed and the final candidate will go through the senate confirmation process during the 2023 Regular Legislative Session.

6 Mr. Morris motioned to grant authority to the Personnel Committee to find and hire a search firm to conduct a search for a superintendent. Dr. Bell seconded the motion and all approved without objection.

The motion was seconded by Mr. Morris and all approved without objection.
