C. Requests for Waiver of 150 Hour Requirement

The following requests for waiver of the 150 hour requirement were considered by the Board pursuant to La. Rev. Stat. §37:75(C)(3), which provides that an applicant who has attained a baccalaureate degree prior to January 1, 1992 from a Louisiana university may be exempt from the 150 hour requirement in certain situations.

1. Request No. 1

Upon motion by Mr. Bergeron, seconded by Mrs. Cochran and unanimously adopted, the Board approved a request for a waiver of 21 hours toward the 150 hour requirement, and waived additional coursework, needed to sit for the CPA exam.

2. Request No. 2

Upon motion by Mr. Bergeron, seconded by Mrs. Hutchinson and unanimously adopted, the Board approved a request for a waiver of 4 hours toward the 150 hour requirement needed to sit for the CPA exam.

3. Request No. 3

Upon motion by Mr. Harris, seconded by Mr. Bergeron and unanimously adopted, the Board approved a request for a waiver of 1 hour toward the 150 hour requirement needed to sit for the CPA exam.

D. Request for Extension of Conditional Credit

The Board considered a request for extension of conditional credit from a candidate who has had difficulty returning to the United States from his home country, where he was seeking prospective employment last year.

Upon motion by Mr. Harris, seconded by Mr. Bergeron and unanimously adopted, the Board granted extensions of AUD, BEC and REG credits until August 31, 2010, in the event that the candidate does not make a passing score on the FAR section that he was able to take on January 4, 2009.

IX. RECURRING MATTERS AND DEFERRED ITEMS

A. NASBA

1. Nomination for Vice Chair of NASBA (TAB 8)

Executive Director Mr. Henderson informed the Board that Board Member Mr. Harris is currently serving his fourth year as NASBA Director at Large and has served as the Southwest Regional Director. The NASBA Nominating Committee is currently accepting nominations for Vice Chair.

Upon motion by Mr. Bergeron, with a unanimous second, the Board approved a draft of a letter to the NASBA Nomination Committee recommending Mr. Harris for Vice Chair of NASBA.

2. Other NASBA Items

Mr. Harris and Mr. Henderson reported on other NASBA matters.

B. Society of Louisiana CPAs (LCPA)

Grady R. Hazel, CPA, Executive Director of the LCPA, discussed matters of interest to the Board and the profession, such as:

IRS registration and testing of tax preparers Mobility / Substantial Equivalency

Mr. Hazel also requested that the Board consider changing the due date for CPE reporting forms from December 31st to a subsequent date to allow time for completion of courses at the end of subsequent reporting periods.

Mr. Hazel also informed the Board that the LCPA ethics course is currently being updated for the 2010 - 2012 reporting period. He requested examples of cases or advisory opinions the Board may have issued.

C. Board Website

Mr. Henderson reported to the Board that he plans to update the CPE page on the Board's website to include an explanation that, with respect to self-study CPE, only "interactive" self study will be accepted. Interactive allows for one for one credit based on average hours whereas non-interactive only allowed CPE credit at one-half the average completion time. The Board asked that Mr. Henderson proceed with having the website redesigned and updated including a changing the layout and the color scheme that has been used for several years.

D. Board's Office – Space at Benson Tower

Mr. Henderson informed the Board that the Board's office received correspondence from Commissioner of Administration Angele Davis exempting the Board from having to relocate to Benson Tower.

E. Report by Peer Review Oversight Committee (PROC)

Mr. Henderson reported that Mr. Updegraff submitted a quarterly report on the AICPA Peer Review Program administered by the Society of Louisiana CPAs: The Peer Review acceptance subcommittee held four telephone conference calls from October 9, 2009 through January 19, 2010. Six firms were given a *Fail* assessment. These firms will receive a letter from the Board as had been approved at the October 2009 Board meeting.

F. Peer Review Compliance

Mr. Henderson reported to the Board on communications to CPA Firms that have failed to timely complete their required Peer Review.

Board Member Mr. Bruno was assigned as Investigating Officer on cases relating to Firms with Peer Review issues.

G. Further Information Concerning Timing of an Administrative Hearing

Mr. Henderson and Mr. Cognevich discussed the timing of a potentially lengthy Administrative Hearing, currently tentatively scheduled for the April 2010 Board Meeting.

X. NEW MATTERS

A. CPE Items

1. Ethics Course for the 2010 – 2012 CPE Reporting Period

Mr. Henderson reported that he had received updates from Dr. Clay and Pass Online for their ethics courses for the 2010 - 2012 reporting period. Mr. Bergeron reported that he had taken the Pass Online course and was satisfied with its coverage.

2. CPE Extensions

Mr. Cognevich reported that, to date, the following extensions have been granted.

One extension is pending, awaiting receipt of documentation.

3. Requests for Waiver of CPE Considered Since October 2009 Meeting

a. CPE Waiver Request No. 1

Upon motion by Mr. Bergeron, seconded by Miss Honoré and unanimously adopted, the Board granted the CPA's request for a waiver of 79 hours due to medical situations.

b. CPE Waiver Request No. 2

Upon motion by Mr. Bergeron, seconded by Mrs. Hutchinson, by a vote of 6-1, the Board determined there were insufficient reasons to grant a waiver of CPE in this matter, and therefore denied the CPA's request. Board Member Mr. Harris voted to approve the waiver.

4. CPE Waiver Request No. 3

A CPA submitted a request for a waiver of 120 hours of CPE for the 2007 – 2009 reporting period, due to medical reasons.

After reviewing the information provided by the CPA, upon motion by Mrs. Cochran, seconded by Mrs. Hutchinson and unanimously adopted, the Board waived 80 hours of the 120 hour requirement, subject to receipt of satisfactory medical documentation. The Board granted an extension to June 30, 2010 for completion of the remaining 40 hours of CPE. The 40 hours must include completion of one of the required Board-approved ethics courses. The Board also determined, as a condition for the waiver, that the CPA must complete 40 hours of CPE for the requirement for the current three year reporting period (2010 – 2012) by December 31, 2010, and provide evidence of completion to the Board's office.

5. CPE Waiver Request No. 4

A CPA submitted a request for a waiver of 20 hours of CPE for the 2007 – 2009 reporting period, due to medical reasons.

After reviewing the information provided by the CPSA, upon motion by Miss Honoré, seconded by Mrs. Hutchinson and unanimously adopted, the Board waived the 20 hours of CPE, subject to a doctor's verification of the CPA's medical issues.

B. Request for Authorization for Continuation of Firm Single Owner Firm – Death of Owner

William Russell Durden passed away on December 16, 2009. Mr. Durden practiced as a CPA as a solely owned LLC. La. Rev. Stat. §37:77.1 provides that authorization of the continuation of the firm for up to twelve months shall be granted by the board when the required documents have been provided to the Board. Mr. Cognevich reported that the required documents were submitted to the Board's office

Upon motion by Mr. Bergeron, seconded by Miss Honoré and unanimously adopted, the Board granted authority for the Firm of William R. Durden, CPA, APAC to continue to operate for a period of up to twelve months.

C. Amendment to Professional Service Contract - Albert J. Derbes III

Upon motion by Miss Honoré, seconded by Mr. Bergeron and unanimously adopted, ___, the Board approved an amendment to the professional service contract for Albert J. Derbes, III in the amount of \$40,000 for the July 1, 2009 – June 30, 2010 fiscal year.

D. Interpretation of Practice as a CPA

Mr. Henderson discussed a letter that was submitted to the Board's office for confirmation of experience for an applicant. The letter is from a licensed CPA who is employed in a non-CPA accounting firm owned by an unlicensed person(s), and raises some issues concerning practice as a CPA.

The Board determined that as long as the individual did not use the CPA title, or engage to prepare financial statements in his or her name or have final responsibility for the work product, a licensed CPA could be an employee of a non-CPA accounting firm that prepared and submitted financial statements to it clients.

XI. INFORMATION ITEMS AND ANNOUNCEMENTS

A. Change in Mileage Reimbursement Rate for Board Travel

Board members were informed that the state had reduced the amount of the mileage reimbursement rate for use of personal vehicles from \$.52 per mile to \$.48 per mile, effective December 21, 2009.

B. Mailing of 2010 Annual Renewal Notices
