## MINUTES

# DECEMBER 12, 2014

## LICENSING AND CONTINUING EDUCATION

Vinny Borrello reported on the Licensing Committee. The first item on the agenda was passed.

There was a discussion about holding a recognition ceremony once a year, at the end of the year.

David Marcello will look into rules governing court reporters completing transcripts after retirement.

On motion by Suzette Magee and second by Laura Putnam, the Board approved the request for inactive status of Sheri DeBlieux and Sandra Mueller. Motion carries.

On motion by Suzette Magee and second of John Andressen, the Board approved the request for retirement status of Mary Travis.

On motion by Milton Donegan and second of Laura Putnam, the Board approved the request for retirement status of Beverly Borne.

On motion by Vinny Borrello and second of Suzette Magee, the Board approved the requests for discontinued CDRs in globo.
