Mr. Anderson reviewed the exhibit packet and provided testimony to the board. Mr. Demmons entered the exhibit packet into evidence, and it was admitted. On motions made by Mr. Gallo, seconded by Mr. Temple, and unanimously passed, the board found NEVELS ELECTRIC LLC to be in violation and assessed a penalty of the maximum fine plus \$1,000 in administrative costs.

On motion made, seconded, and unanimously passed, the rehearing was granted. Alonso Alvarado was present on behalf of ALONSO'S AZTEC TILE & GRANITE LLC and was sworn in. Ms. Morgan gave a summary of the allegations. Mr. Alvarado entered a plea of no contest. On motion made, seconded, and unanimously passed, the plea was accepted. Investigator Blaine Anderson, who was previously sworn, was called to the stand. Mr. Anderson reviewed the exhibit packet and provided testimony to the board. Mr. Landreneau entered the exhibit packet into evidence, and it was admitted. Mr. Alvarado provided testimony to the board. Mr. Tillage made a motion to assess a penalty of a \$1,000 fine plus \$1,000 for administrative costs. After discussion, Mr. Temple made an amended motion to assess a \$7,500 fine plus \$1,000 for administrative costs to be reduced to a \$1,000 fine plus \$1,000 for administrative costs provided a license is obtained within 180 days.
