A. Southeast Louisiana Flood Protection Authority-East (SLFPA-E):

- 1. Motion to approve the SLFPA-E Comprehensive Emergency Management Plan and the revised O.L.D., LBBLD and EJLD Emergency Operations Procedures (EOP) Manuals and to authorize all actions under the Plan and EOP Manuals.
- 2. Motion to approve exercising the one-year renewal option provided in the Agreements for Professional Services for Professional Coastal, Geotechnical and Hydraulic Engineering Services and for Professional Surveying Services on an Indefinite Delivery-Indefinite Quantity (ID-IQ) basis.
- 3. Motion to approve exercising the one-year renewal option provided in the Agreement for Professional Services with Tetra Tech for Professional Engineering Services to assist in the evaluation and certification of the Maxent Levee in New Orleans East and the Forty Arpent Levee in the Lower Ninth Ward and St. Bernard Parish.

- 4. Motion to formally recognize certain Special Levee Improvement (SLIP) Fund fund balance commitments by recording the commitments on the O.L.D. accounting records.
