- 2. Motion to authorize an increase of \$24,841.57 to the contract amount (increases contract from \$63,449.00 to \$88,290.57) for the contract with Cycle Construction Company, LLC for the London Avenue Canal Levee Repair Project.
- 3. Motion to authorize the SLFPA-E President or Director of Engineering and Operations to execute Amendment No. 2 to the Intergovernmental Agreement between the CPRA and SLFPA-E to increase HNTB's Task by \$22,228, for an amount not to exceed \$150,228 for construction management, which shall be financed 100 percent by the SLFPA-E, for the LPV 00.2 Levee Lift Project.
- 4. Motion to authorize an amendment to Task Order No. 2 issued to Linfield Hunter and Junius, Inc., to provide an increase of \$39,919.03 (increasing Task Order No. 2 from \$164,316.98 to \$204,236.01) for Engineering During Construction and Construction Management for the LPV 19.2 and 20.1 Levee Lift Project.

- 5. Motion to allow Ceres Environmental Services, Inc., Cycle Construction, LLC, and DRC Environmental Services to contract, in accordance with FEMA requirements, with the SLFPA-E to provide a proposal for the timely removal of post hurricane and high water event debris on levee rights-of-ways and public properties to an approved disposal site, and to authorize the SLFPA-E Director of Engineering and Operations or Chief Administrative Officer to sign a Contract and any and all other documents necessary to carry out the above
- 6. Motion to allow Tetra Tech, Inc. to contract with the SLFPA-E, in accordance with FEMA requirements, to provide a proposal for the monitoring of post hurricane and high water event debris removal and disposal services, and to authorize the SLFPA-E Director of Engineering and Operations or Chief Administrative Officer to sign a Contract and any and all other documents necessary to carry out the above.
- 7. Motion to allow Cycle Construction, LLC, Hydradyne LLC, and M.R. Pittman Group, LLC to contract, in accordance with FEMA requirements, with the SLFPA-E to provide a proposal after a storm or other qualifying event for the operation and repair of flood control structures owned and operated by SLFPA-E, and to authorize the SLFPA-E Director of Engineering and Operations or Chief Administrative Officer to sign a Contract and any and all other documents necessary to carry out the above.
