- 2. Motion to authorize the execution of a Cooperative Endeavor Agreement between the FPA, on behalf of the Orleans Levee District (O.L.D.), and the Constable for the City of New Orleans, for occupying 1,160 square feet of space in the O.L.D. Police Station located at 6799 Elysian Fields Avenue.

Motion to approve the selection of the AIMS Group, Burk Kleinpeter, Inc., Design Engineering, Inc., ECM Consultants, Meyer Engineers, LTD and NY & Associates for the purpose of entering into Indefinite Delivery-Indefinite Quantity (ID-IQ) Contracts with said consultants to provide Construction Administration, Resident Inspection and other Inspection Services, and to authorize the FPA Chief Administrative Officer to negotiate and execute the final ID-IQ Contracts with the approved consultants.
