New Business:

1. Adopt the adjusted millage rates for the tax year 2027 on all property subject to taxation by the Algiers Levee District.
 2. Set forth the adjusted millage rate and roll forward to millage rate not exceeding the maximum authorized rate and adopt the adjusted millage rates after reassessment and rolling forward to rates not to exceed the prior year's maximum. The estimated amount of tax revenues to be collected in the next year from the increased millage is \$3,721,977.60, and the amount of increase in taxes attributable to the millage increase is \$440,201.27.
 3. Adopt other authorized millages or taxes: adopt a resolution of the Board of Commissioners for the Southeast Louisiana Flood Protection Authority – West Bank, for and on behalf of the Algiers Levee District, to levy the millage(s) on the 2027 tax roll on all property subject to taxation.
