## a. Louisiana Secretary of State (SOS)

SOS would like to change banks to avoid this monthly expense.

## b. Department of Public Safety, Youth Services, Office of Juvenile Justice

Request to open a new ZBA bank account at JP Morgan Chase, Alexandria, Louisiana. Acadiana Center for Youth is a newly opened secure care facility and requires funds to be separate from other locations. d. Department of Public Safety & Corrections/Public Safety Service/Office of Motor Vehicles

Request to close an existing account at Capital One, Mansfield, Louisiana and open a new bank account at Citizens National Bank, Mansfield, Louisiana. The Mansfield Capital One Branch closed effective 5/6/19. These funds are swept to State Treasury Central Account daily, thus a new account needs to be established to replace the Capital One account. #### e. Louisiana Department of Insurance
