In accordance with R.S. 42:17.1 this notice shall serve as certification of the Greater New Orleans Expressway's Commissions ("GNOEC") inability to otherwise operate in accordance with the Louisiana Open Meetings Law due to such a meeting being detrimental to the health, safety, and/or welfare of the public as a result of the emergency conditions from Tropical Storm Francine as declared by Governor Jeff Landry on September 9, 2024 by JML 24-142.
