May 29, 2012 - The Public Oyster Seed Ground Vessel Permit Appeals Board will meet on Tuesday, June 5, at 10 a.m. in Suite 200 of the University of New Orleans Advanced Technology Building located at 2021 Lakeshore Drive in New Orleans.

Agenda items for the meeting of the Public Oyster Seed Ground Vessel Permit Appeals Board are as follows:

3. Discussion of Act 85 of the 2012 Regular Legislative Session
4. Set next meeting date

This board was established by Act 922 of the 2008 Regular Legislative Session for the purpose of hearing appeals of vessel permit denials by the Louisiana Department of Wildlife and Fisheries (LDWF). Act 922 requires that anyone commercially harvesting oysters on the public oyster seed grounds and reservations, except Calcasieu Lake and Sabine Lake, must do so from a vessel holding a public oyster seed ground vessel permit issued by LDWF.
