WHEREAS, the Governor renewed the current state of emergency relative to COVID-19 in Proclamation No. 74 JBE 2020; and

WHEREAS, the Governor extended certain restrictions relative to the current state of emergency in Proclamation No. 75 JBE 2020; and

WHEREAS, the restrictions in the above referenced proclamations include a limitation on the number of people that may occupy the Board of Pharmacy office building at the same time – 50% of the total occupancy as determined by the State Fire Marshal; and

WHEREAS, the Prescription Monitoring Program Advisory Council has determined it necessary to convene its regular quarterly meeting; and

WHEREAS, the Council will be unable to conduct its meeting in compliance with the Open Meetings Law and the above referenced proclamations without the use videoconferencing technology; then

THEREFORE, the Council has determined it appropriate, pursuant to the provisions of Subsection 2.C of Proclamation No. 75 JBE 2020, to utilize videoconferencing technology for its July 8, 2020 meeting; and further,
