Certification of Meeting Conducted Pursuant to La. R.S. 42:17.1

In accordance with R.S. 42:17.1, this notice shall serve as certification of the Governor's Office of Homeland Security and Emergency Preparedness's (GOHSEP) inability to otherwise operate in accordance with the Louisiana Open Meetings Law due to such a meeting being detrimental to the health, safety, and/or welfare of the public as a result of the public health emergency, as declared by Governor John Bel Edwards on February 10, 2021 by 18 JBE 2021. The GOHSEP will provide for attendance at its essential government meeting on August 10, 2021 via video conference. It is essential that the GOHSEP continue to operate to address matters directly related to its response to the disaster or emergency and/or matters that if delayed will cause a curtailment of vital public services or severe economic dislocation and hardship and/or matters that are critical to the continuation of its business and that are not able to be postponed due to legal requirements and/or other matters that presiding officer has determined are critical or time-sensitive.
