### **CERTIFICATION**

Therefore, LSBEP shall hold this board meeting via Zoom.us, open and assessable to any member of the public to participate via video conference or telephone, except those portions of the meeting which are held in Executive Session.

Further, I certify that as a result of the state of Emergency created by HURRICANE DELTA, travel to Baton Rouge for some members and individuals with a vital interest in this meeting would create a hardship. Additionally, as a result of the state of Emergency created by COVID-19 and the increased risk of contracting COVID-19 by those in attendance, including the public, such increased risk of the spread of the disease would further increase the risk of spread to the general public, and a physical meeting would thus be detrimental to the health, safety and welfare of the public and impede the vital operations of the LSBEP.

Further, I certify the items docketed to be discussed are matters that are critical to due process licensing issues and directly related the protection of the health, safety and welfare of the public. For these reasons, the matter to be discussed is not able to be delayed.

Further, I certify that this Notice and Agenda have been posted on the website of the LSBEP, emailed to individuals and the news media who have requested to receive notices of meetings of the LSBEP, and widely distributed to every known news media outlet that broadcasts or publishes news within Louisiana.
