**March 15, 2023, Residential Subcommittee Meeting Minutes [excerpt]**

No one was present on behalf of CAVALIER HOME IMPROVEMENT, L.L.C. Ms. Morgan gave a summary of the allegations. Brad Hassert, Compliance Director, who was previously sworn, was called to the stand. Mr. Hassert reviewed the exhibit packet and provided testimony to the board. Mr. Landreneau entered the exhibit packet into evidence, and it was admitted. On motions made, seconded, and unanimously passed, the board found CAVALIER HOME IMPROVEMENT, L.L.C. to be in violation and assessed the maximum fine plus \$1000 in administrative costs and issued a cease and desist order.
