In-person Meeting Attendance Protocol

All persons attending the meeting in person shall utilize appropriate protective health measures, social distancing and observe the protocols below:

- Everyone entering the LaSalle building must go through the temperature checkpoint at the building entrance facing North Third Street. - Martco L.L.C. (Application #20180296-ITE and #20190393-ITE): Upon approval by the Board of Commerce and Industry at the June 24, 2020 meeting, these two (2) ITEP Applications were sent to the Natchitoches Parish local bodies for consideration. Rules provide 30 days to provide notice to LED that the council will take action on the application and additional 30 days to take action approving or denying the application. LED received a request from Martco L.L.C. ("Martco") to appeal the Natchitoches Parish Council's decision to deny their ITE property tax abatements for both applications at the board meeting held on August 17, 2020. Martco is requesting these denials be deemed approved or, alternatively, have an opportunity to be placed on the council agenda for a re-vote, due to no notice of agenda being given to Martco or made public prior to the meeting. Subsequently, on September 28, 2020, the council took further action to reconsider and approve the application. Timeline of relevant events:
 - April 21, 2020 the Board unanimously approved a motion acknowledging that the suspension of legal deadlines ordered by proclamation applies to business incentives under the jurisdiction of the Board of Commerce and Industry and further extended those deadlines an additional 30 days.
 - June 25, 2020 BC&I approves the Martco applications
 - June 29, 2020 LED notifies locals of BC&I approval by email
 - July 24, 2020 30-day extension of suspended deadlines begin
 - July 25, 2020 Original date of 30 day notice period for local governmental entity to provide LED Notice of Action of the intention to place the ITEP application on a public meeting agenda extended to August 23, 2020 pursuant to the suspension period.
 - August 18, 2020 Notice of Action reflecting a DENIAL by the Natchitoches Parish Council submitted to LED
 - August 23, 2020 Extension of suspended deadlines expires
 - August 25, 2020 End of original 60 day window for local government entities to take action
 - September 15, 2020 MARTCO provides LED notice of request to appeal the parish council's denial lack of notice of the council meeting
 - September 28, 2020 LED receives correspondence from Natchitoches Parish Council reconsidering and approving Martco's ITE request

• Praxair, Inc. application #20190076-ITE was approved by the Board of Commerce and Industry at the December 13, 2019 meeting, following which Notice of Board Approval was sent to the St. James Parish Council, St. James Parish School Board, and St. James Parish Sheriff for their consideration along with LED forms for providing the required notice(s) of action back to LED of either denying or approving the ITEP application.

On February 6, 2020, LED received the Notice of Action from the St. James Parish Council in an altered form indicating: "St. James Parish Council has conducted a public meeting on Industrial Tax Exemption Application #20190076-ITE and voted to DENY the Application as presented by the Louisiana Department of Economic Development in the 12/12/19 Contract for Exemption of Ad Valorem Taxes with Praxair, Inc. Alternatively, St. James Parish Council has agreed to APPROVE Industrial Tax Exemption Application #20190076-ITE provided that the alternative yearly exemption percentages of ad valorem taxes as listed in the attached Resolution No. 20-40 are incorporated into the final Contract for Exemption of Ad Valorem Taxes with Praxair, Inc." On the next day, the St. James Parish School Board and St. James Parish Sheriff returned Notices of Action to LED indicating the same action as the Parish Council.

LED interpreted these notices from the St. James Parish local officials as denials. However, because the Notices of Action were not provided on the standard Notice of Action form provided by LED, LED requested that the Board make a determination on the action taken by the St. James Parish local officials. Upon discussion at the BC&I meeting on February 21, 2020 meeting, the special request was ultimately deferred by the Board of Commerce and Industry for the local officials to determine whether they wanted to present a new Notice of Action on the LED form before a determination by the Board.

On October 1, 2020 LED received notification that each of the St. James local entities (Parish, School Board, and Sheriff) sent new Notices of Action in the form provided by LED, with each denying the Application. On the same date, LED received a request from Praxair to appeal the rejection of Application #20190076 by the St. James local entities upon grounds that the denials are not in compliance with the ITEP Rules.

Rule 503(H):

- H. Upon the board's approval of an application, the department, on behalf of the board, shall, within three business days, transmit a copy of the approval and Exhibit A by mail or electronic mail to each local governmental authority and the assessor and the department shall post notice of the board's approval of an application on the department's website within three business days of approval, upon which date shall begin a notice period of 30 days for the parish governing authority (speaking on behalf of the parish and all parish bodies who are located outside the boundary of any affected municipality who receive a millage), the school board, any applicable municipality (speaking on behalf of the municipality and all municipal bodies who receive a millage) and the sheriff to initiate action to approve or reject the board's action as provided hereinafter.
- 1. Within the 30-day notice period, the parish governing authority, the school board, or any affected municipality may identify the application on the agenda of a public meeting notice and the sheriff may issue a letter approving or denying the application, and notice of these actions shall be given to the department within 3 business days. A local governmental entity that places the application on the agenda for a public meeting will have an additional 30 days (for a total of 60 days from the start of the notice period) to conduct a public meeting issuing a resolution approving or rejecting the board approved application, and notice of the issuance shall be given to the department within 3 business days. If a local governmental entity does not take action or provide notice as required herein, then the application will be deemed approved by each such entity.
