3. **L25-077 - Acadia Parish, Consolidated Gravity Drainage District No. 1** - 8.56 mills tax, 10 years, 2026-2035, constructing, improving, maintaining and operating gravity drainage works, including the acquisition of equipment.
4. **L25-078 - Acadia Parish, Iota Fire Protection District** - **(1)** 10.60 mills tax, 10 years, 2026-2035, maintaining and operating fire protection facilities, purchasing fire trucks and other firefighting equipment and paying the cost of obtaining water for fire protection purposes; **(2)** 11.49 mills tax, 10 years, 2026-2035, acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment and paying the cost of obtaining water for fire protection purposes.
5. **L25-079 - Acadia and Evangeline Parishes, Acadia-Evangeline Fire Protection District** - 4.10 mills tax, 10 years, 2026-2035, acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment and paying the cost of obtaining water for fire protection purposes.
6. **L25-098 - Avoyelles Parish Police Jury** - Adopt a Home Rule Charter for the Parish of Avoyelles, prepared and submitted by the Avoyelles Parish Home Rule Charter Commission.
7. **L25-099 - Beauregard Parish Police Jury** - **(1) Road District No. 2** - 6.13 mills tax, 10 years, 2026-2035, improving, maintaining and keeping in repair the roads; **(2) Road District No. 7** - 32.2 mills tax, 10 years, 2027-2036, constructing, improving and maintaining roads and bridges; **(3) Road District No. 8** - 26.46 mills tax, 10 years, 2027-2036, constructing, improving and maintaining roads and bridges.
8. **L25-087 - Caddo Parish, Fire District No. 8** - **(1)** 12.56 mills tax, 20 years, 2026-2045, acquiring, constructing, maintaining and operating fire protection and emergency medical service facilities, purchasing fire trucks and other fire fighting or emergency medical service equipment and paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service, and salaries; **(2)** 4.16 mills tax, 10 years, 2029-2038, acquiring, constructing, improving, maintaining and/or operating fire protection facilities, obtaining water for fire protection purposes, and acquiring, constructing, improving, maintaining and/or operating emergency medical facilities; **(3)** \$75 service charge, 10 years, 2030-2039, fire protection services.
9. **L25-111 - East Baton Rouge Parish, Southern Heights Neighborhood Crime Prevention and Improvement District** - Not exceeding \$100 parcel fee, 10 years, 2026-2035, to increase once after at least five years provided said fee not exceed \$150, aid in crime prevention and to add to the security, and serve needs by funding beautification and improvements for the overall betterment.
10. **L25-084 - Iberville Parish, City of Plaquemine** - **(1)** 3.1 mills tax, 10 years, 2027-2036, improving, maintaining and operating the Police Department; **(2)** 3.1 mills tax, 10 years, 2027-2036, improving, maintaining and operating public buildings.

11. **L25-096 - Lafayette Parish School Board, Consolidated School District No. 1** - 7.79 mills tax, 10 years, 2027-2036, giving additional support to the public elementary and secondary schools.
12. **L25-083 - Lafourche Parish, Town of Golden Meadow** - (1) 5.25 mills tax, 10 years, 2027-2036, maintaining levees; (2) 5.25 mills tax, 10 years, 2027-2036, maintaining drainage works.
13. **L25-102 - LaSalle Parish Police Jury** - (1) 6.5 mills tax, 10 years, 2026-2035, capital construction and/or equipment and operating and maintaining the Parish Library and its branches; (2) 2.21 mills tax, 10 years, 2026-2035, capital construction and/or equipment and supporting, operating and maintaining the Parish Library and its branches.
14. **L25-103 - LaSalle Parish School Board, School District No. 1-A** - 1.98 mills tax, 10 years, 2027-2036, maintaining and operating schools and making improvements to the public schools.
15. **L25-092 - Livingston Parish, Recreation District No. 3** - 15.0 mills tax, 10 years, 2026-2035, operating and maintaining the District.
16. **L25-091 - Madison Parish Police Jury** - (1) 7.0 mills tax, 10 years, 2027-2036, constructing improving, equipping, operating, maintaining and supporting the courthouse and jail; (2) 1.18 mills tax, 10 years, 2027-2036, 50% for maintaining and operating the Madison Parish Health Unit and 50% for supporting the general fund; (3) 9.03 mills tax, 10 years, 2027-2036, 50% for providing and maintaining garbage collection and disposal services and 50% for constructing, improving, equipping, operating and maintaining public works and roads.
17. **L25-080 - Morehouse Parish Police Jury** - 0.6 mills tax, 10 years, 2026-2035, maintaining and operating public buildings.
18. **L25-097 - Rapides Parish Police Jury, Road District No. 5A Sales Tax District** - 2% sales tax, 10 years, beginning January 1, 2026, constructing, improving, maintaining and keeping in repair the public roads, highways, bridges and related drainage facilities.
19. **L25-100 - St. Helena Parish Police Jury** - (1) **Road District No. 5** - 5.12 mills tax, 10 years, 2026-2035, building, rebuilding, resurfacing, maintaining and keeping in repair all of the public roads, highways and bridges; (2) 7.17 mills tax, 10 years, 2026-2035, building, rebuilding, resurfacing, maintaining and keeping in repair the public roads, highways and bridges; (3) **Road District No. 2, Sub-Road District No. 1** - 5.0 mills tax, 10 years, 2026- 2035, maintaining and keeping in repair the public roads, highways and bridges; (4) **Road District No. 2, Sub-Road District No. 2** - 6.0 mills tax, 10 years, 2026-2035, building, rebuilding, resurfacing, maintaining and keeping in repair the public roads, highways and bridges.
20. **L25-085 - St. Landry Parish, Bayou Mallet and Plaquemine Gravity Drainage District No. 10** - 12.19 mills tax, 10 years, 2025-2034, constructing, maintaining, operating and improving the gravity drainage works.
21. **L25-086 - St. Landry Parish, South Gravity Drainage District No. 1, Ward 1** - 3.49 mills tax, 10 years, 2026-2035, acquiring, constructing, improving, maintaining and/or operating drainage works.
22. **L25-108 - St. Landry Parish, Town of Washington** - 0.20% sales tax, 10 years, beginning January 1, 2026, street, sidewalk and drainage improvements and maintenance and funding proceeds into bonds.

26. **L25-094 - Terrebonne Parish, Fire Protection District No. 9** - 16.46 mills tax, 10 years, 2027-2036, acquiring, constructing, maintaining and operating fire protection facilities and paying the cost of obtaining water for fire protection purposes, including fire hydrants rentals and service.
27. **L25-109 - Terrebonne Parish, Schriever Fire Protection District** - 15.0 mills tax, 10 years, 2027-2036, acquiring, constructing, improving, maintaining and/or operating fire protection and emergency medical service facilities, purchasing fire trucks and other fire fighting or emergency medical service equipment, and obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.
28. **L25-095 - Vernon Parish School Board - (1) Wardwide School District No. 160, Ward 3** - 18.77 mills tax, 10 years, 2027-2036, giving additional support to the public elementary and secondary schools, including paying the cost of operating and maintaining public school buildings; **(2) Wardwide School District, Ward 7** - 17.42 mills tax, 10 years, 2027-2036, giving additional support to the public elementary and secondary schools, including paying the cost of operating and maintaining public school buildings; **(3) Hornbeck School District No. 143** - 10.39 mills tax, 10 years, 2026-2035, maintaining the gymnasium and other K-12 school buildings at Hornbeck High School; **(4) Wardwide School District No. 161, Ward 6** - 10.0 mills tax, 10 years, 2026-2035, giving additional support to public elementary and secondary schools, including paying the cost of operating and maintaining public school buildings; **(5) Wardwide School District No. 151, Ward 8** - 10.21 mills tax, 10 years, 2026-2035, giving additional support to public elementary and secondary schools, including paying the cost of operating and maintaining public school buildings.
29. **L25-081 - Washington Parish, City of Bogalusa** - 2.75 mills tax, 10 years, 2026-2035, providing retirement and pension benefits for the City of Bogalusa Retirement System.
30. **L25-104 - Washington Parish, Fire Protection District No. 1** - 15.0 mills tax, 10 years, 2026-2035, acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, including the cost of obtaining water for fire protection purposes.
31. **L25-082 - Webster Parish School Board - (1) School District** - 5.78 mills tax, 10 years, 2028-2037, additional aid and support; **(2)** 2.48 mills tax, 10 years, 2028-2037, providing repairs, upkeep, additions and maintenance of buildings and physical properties; **(3) Consolidated School District No. 3** - 25.21 mills tax, 10 years, 2028-2037, construction, renovation, repair and improvement of public school buildings and facilities, including acquisition of furniture, fixtures, equipment and other school related property; **(4) Cotton Valley School District No. 12** - 5.0 mills tax, 10 years, 2027-2036, additional support to public schools, including acquiring, constructing, repairing, improving, maintaining and/or operating schools and school related facilities, equipment and programs; **(5) Sarepta School District No. 35** - 5.78; **(6) Sales Tax School District No. 6** - ½% sales tax, to be levied in perpetuity, beginning April 1, 2029, constructing, acquiring, improving, equipping, furnishing and/or maintaining schools and school related facilities, including, to the extent feasible, those school projects set forth in the Report of the Webster Parish School District No. 6 Planning Committee approved by the Webster Parish School Board on November 3, 2003, and funding into bonds for the aforesaid capital purposes.
32. **L25-105 - West Carroll Parish School Board, School District** - 6.51 mills tax, 5 years, 2027-2031, additional support.

LOCAL POLITICAL SUBDIVISIONS - BONDS - FINAL APPROVAL

33. **L25-060 - Concordia Parish, Village of Clayton (DEQ Project)** - Not exceeding \$1,727,000 Sewer Revenue Bonds, not exceeding 0.95%, not exceeding 20 years, constructing and acquiring additions, extensions and improvements to the wastewater system, including equipment and fixtures.
34. **L25-113 - Franklin Parish, Town of Winnsboro** - Not exceeding \$650,000 Revenue Bonds, not exceeding 7%, not exceeding 30 years, acquiring land and related buildings and improvements for a new municipal complex.
35. **L25-107 - Lafayette Parish School Board** - Not exceeding \$70,000,000 Sales Tax Revenue Bonds, not exceeding 6%, not exceeding 30 years, constructing and acquiring capital improvements, including the acquisition of lands for building sites and playgrounds, purchasing, erecting and improving school buildings and related facilities, and acquiring the necessary equipment and furnishings therefor.
36. **L25-110 - St. Charles Parish Council (DEQ Project)** - Not exceeding \$10,000,000 Taxable Limited Tax Bonds, not exceeding 0.95%, mature no later than March 1, 2045, acquiring, constructing and improving wastewater facilities and systems, including those owned and operated by Consolidated Waterworks and Wastewater District No. 1.

37. **S25-014 - Louisiana Housing Corporation (Capstone at Covington Place Project)** - Not exceeding \$18,000,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 8%, not exceeding 40 years, acquiring, constructing, and equipping of an 80-unit multifamily housing development in Covington.

38. **S25-015 - Louisiana Community Development Authority (Vermilion Parish School Board Project)** - Not exceeding \$20,000,000 Revenue Bonds, not exceeding 7%, not exceeding 25 years, acquiring, constructing, and/or improving schools and other related facilities, including equipment and furnishings therefor.
39. **S25-016 - Louisiana Community Development Authority (Terrebonne Port Commission Project)** - Not exceeding \$7,100,000 Revenue Bonds, not exceeding 7%, not exceeding 25 years, acquisition of immovable property and improvements on property and port facilities, and funding a debt service reserve fund, if necessary.
40. **S25-017 - Louisiana Community Development Authority (Baton Rouge Student Housing L.L.C. Project)** - Not exceeding \$45,000,000 Revenue and Refunding Bonds, not exceeding 9%, not exceeding 35 years, approximately \$18,935,531 Refunding Bonds, refunding Revenue Bonds Series 2003A, approximately \$26,064,469 Revenue Bonds, repaying advances and insurance claims relating to the project, funding capital improvements, if necessary; funding a debt service reserve fund and funding or replenishing certain reserves.

41. **S25-013 - Capital Area Finance Authority** - Not exceeding \$35,000,000 Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 42 years, finance loans to first-time homebuyers within the jurisdictional parishes of CAFA (Parishes of Ascension, East Feliciana, Iberville, Livingston, Pointe Coupee, St. Helena, West Baton Rouge and West Feliciana) and such other parishes whose governing authority executes cooperative endeavor agreements with the Authority pursuant to the Act.
