- 1. At the November 2013 Drug Policy Board meeting, you had approved a Waiver request from the 22<sup>nd</sup> Judicial DA Walter Reed to continue his *Career Criminal Prosecution* project. We seek a motion and approval to allow Mr. Reed's Waiver for subgrant #1433, *Career Criminal Prosecution* in Washington Parish, to apply for subgrant #1440, *Career Criminal Prosecution* in St. Tammany Parish. [eGrants requires a split.]
- Demonstration Projects in different parts of the state. We are now trying to place projects in both central and southeastern Louisiana. This program puts state-of-the-art video recording equipment in newly-soundproofed interrogation rooms, to guarantee the validity of a suspect's statements. We ask the Board to encourage law enforcement Agencies in their area to consider this program.
- 3. At the last meeting, this Board voted on the Baker PD *Criminal Patrols* application; an incorrect ID Number appeared on your ballot. The November Commission ballot had the correct ID Number. For the Record, we want the Board's agreement that the correct ID Number is B12-5-013 rather than B15-5-013. We now ask for a motion and approval for this correction.

4. At the Commission and Drug Board November meetings, there was an incorrect ID Number listed for Baton Rouge *MJTF* on the Sole Source ballots; the correct ID Number is **B11-5-012**, not **B12-5-012**. We now seek a motion to amend both November ballots, as stated.

#### G. Other New Business - Bob Miller

- 1. At the last Board meeting, the Lincoln Parish *MJTF* project **#1438** was approved for \$24,107 rather than for their approved allocation of \$24,560. Their application incorrectly stated the lower amount which the Sheriff's Office corrected shortly after the Commission meeting, with LCLE staff assistance. We now seek a motion and Approval to allow the Award at its proper level of \$24,560.
- 2. The State-Level increase, up to \$25,000, allows LCLE to move Residual funds into *Criminal Records Improvement* (**B10-8-003**), as other Byrne 2010 Subgrants close out <u>and</u> before the Federal end-date of 3/31/2014. We will provide final computation at the Board meeting on May 19, 2014.
