## CERTIFICATE OF INABILITY TO OPERATE DUE TO LACK OF QUORUM – LEDC

In accordance with Executive Proclamation JBE 2020-75, issued by Governor John Bel Edwards on June 4, 2020, the Louisiana Economic Development Corporation ("LEDC") is providing for attendance at a board meeting which will only contain business deemed essential government business via teleconference or video conference as allowed during the pendency of the COVID-19 health emergency. Pursuant to Section 2C of JBE 2020-59, LEDC will provide attendance for the 10:00 am meeting on Thursday, June 11, 2020, via Zoom and in a manner that allows for observation and input by members of the public, as set forth in the Notice posted on June 08, 2020. LEDC would otherwise be unable to operate due to quorum requirements.
