**Certification of Meeting Conducted Pursuant to LA R.S. 42:17.1**

In accordance with LA R.S. 42:17.1, this meeting notice shall serve as certification of the Louisiana Sales and Use Tax Commission for Remote Sellers' inability to otherwise operate in accordance with the Louisiana Open Meetings Law due to such a meeting being detrimental to the health, safety, and/or welfare of the public as a result of the public health emergency, as declared by Governor Edwards on January 12, 2021 by Proclamation No. 7 JBE 2021.

The Louisiana Sales and Use Tax Commission for Remote Sellers ("Commission") will provide for attendance at its essential government meeting via teleconference or video conference as authorized by LA R.S. 42:17.1 during a gubernatorially declared state of disaster or emergency.

As authorized by statute and in light of the ongoing public health emergency, the Commission will provide for attendance for the 11:00 AM meeting on January 14, 2021 via Zoom and in a manner that allows for observation and input by members of the public, as set forth in the meeting notice posted on January 13, 2021.
