

**ORDINANCE NO. 1.**

**AN ORDINANCE MAKING IT UNLAWFUL TO ABANDON OR LEAVE UNATTENDED, ANY VESSEL WITHIN THE JURISDICTION OF THE TWIN PARISH PORT DISTRICT.**

**BE IT ORDAINED**, by the Commissioners of the Twin Parish Port District:

1. It shall be unlawful for any vessel of any type to be abandoned or left unattended for a period of seven days.
2. A vessel is deemed abandoned or unattended if, after giving notice ordering its removal, it is not removed within seven days.
3. Notice is given by affixing same to said vessel.
4. A vessel deemed abandoned or unattended shall be seized and moved at the discretion of the Commissioners of the Twin Parish Port District and at the owner's expense. Said vessel shall not be released to the owner until all expenses are paid.
5. Any vessel seized under this Ordinance shall be sold in accordance with Louisiana Revised Statutes 34:843.

**ORDINANCE NO. 2.**

**AN ORDINANCE MAKING IT UNLAWFUL TO EXTEND BOOMS OR OTHER DEVICES BEYOND THE BEAM OF A VESSEL.**

**BE IT ORDAINED**, by the commissioners of the Twin Parish Port District:

1. It shall be unlawful for any type of vessel, fishing or otherwise, to dock with booms, tackles, or any appurtenances whatsoever extending beyond the width of said vessel in excess of seven feet.
2. Any owner and/or operator of such vessel violating this ordinance shall be fined \$100.00 for each day of said violation.

**ORDINANCE NO. 3.**

**AN ORDINANCE MAKING A NO WAKE ZONE.**

**BE IT ORDAINED**, by the commissioners of the Twin Parish Port District:

1. It shall be unlawful for any vessel to make a wake or travel in excess of idle speed within any area designated as a "No Wake Zone/Idle Speed" by the Commissioners of the Twin Parish Port District.
2. Areas shall be so designated by the placement of "No Wake Zone/Idle Speed" signs.
3. Any owner and/or operator of such vessel violating this ordinance shall be fined \$100.00 for each occurrence.

**ORDINANCE NO. 4.**

**AN ORDINANCE REQUIRING THE PERMITTING OF COMMERCIAL FISHING VESSELS.**

**BE IT ORDAINED**, by the commissioners of the Twin Parish Port District:

1. No vessel shall dock at any public dock regulated under the authority of the Twin Parish Port District without a permit issued by the Commissioners of the Twin Parish Port District or their representatives.
2. Permits shall be displayed on the starboard and port side window of the vessel and shall be subject to inspection by representatives of the Twin Parish Port District.
3. Fees for permits shall be set by the Commissioners of the Twin Parish Port District.
4. Permits may be obtained at the Delcambre Police Station upon payment of the fees and the furnishing of the name, physical address, and phone number of the person responsible for operation of said vessel.
5. Permits shall be renewed by March 31 each subsequent year of operation of such vessel within the jurisdiction of the Twin Parish Port District.
6. Any owner and/or operator of any vessel violating this ordinance shall be fined \$100.00 for each day of said violation.

**ORDINANCE NO. 5.**

**AN ORDINANCE FORBIDDING FISHING ON PUBLIC DOCKS**

**BE IT ORDAINED**, by the commissioners of the Twin Parish Port District:

1. It shall be unlawful for any person to fish, crab, throw cast nets, or swim, from any mooring dock regulated under the authority of the Twin Parish Port District.
2. Any person violating this ordinance shall be fined \$25.00 for each occurrence.

**ORDINANCE NO. 6.**

**AN ORDINANCE FORBIDDING THE SELLING OF SEAFOOD ON PUBLIC DOCKS**
