

BID SUBMISSION INSTRUCTIONS
DELIVERY PROCEDURES TO FOLLOW DURING COVID-19 PANDEMIC

Bid documents may be delivered to the Department of Transportation and Development Headquarters building in Baton Rouge, LA at the address noted below by either hand, courier service or through the US Postal Service. During this time, while bids may still be delivered by US Postal Service, bidders are hereby warned that it is not the most viable option due to lengthy delivery times. Bids **MUST** still be received **before** the date and time set for receiving bid submissions as noted on the Rfx hereof.

NOTE: The time set for receiving bids is Central Standard Time (CST).

HAND OR COURIER SERVICE DELIVERY:

For delivery by **HAND** or **COURIER SERVICE** to our physical location please clearly note, on the outside of the bid envelope, the company's name and complete address, Rfx number and bid opening date as shown below. Bidders are hereby advised bids must be delivered to the **Security Desk** on the first floor of the main DOTD Headquarters building at the address noted below. Omission of the company name and complete address, Rfx number and bid opening date could delay delivery of your bid and/or rejection if the bid is received after the opening deadline.

Bidders are hereby advised that the U.S. Postal Service does not make deliveries to our physical location and this chosen means of delivery may cause the a delay in delivery during this time.
