18. NEW PRODUCTS:

NO REMANUFACTURED, DEMONSTRATOR, USED OR IRREGULAR PRODUCT WILL BE CONSIDERED FOR PURCHASE UNLESS OTHERWISE SPECIFIED IN THE SOLICITATION. THE MANUFACTURER'S STANDARD WARRANTY WILL APPLY UNLESS OTHERWISE SPECIFIED IN THE SOLICITATION.

19. CONTRACT RENEWALS:

20. CONTRACT CANCELLATION:

TERMINATION FOR NONCOMPLIANCE:

LSUHSC HAS THE RIGHT TO CANCEL ANY CONTRACT, IN ACCORDANCE WITH PURCHASING RULES AND REGULATIONS, FOR CAUSE INCLUDING BUT NOT LIMITED TO THE FOLLOWING:

- (1) FAILURE TO DELIVER WITHIN THE TIME SPECIFIED IN THE CONTRACT;
- (2) FAILURE OF THE PRODUCT OR SERVICE TO MEET SPECIFICATIONS, CONFORM TO SAMPLE QUALITY OR TO BE DELIVERED IN GOOD CONDITION;
- (3) MISREPRESENTATION BY THE CONTRACTOR;
- (4) FRAUD, COLLUSION , CONSPIRACY OR OTHER UNLAWFUL MEANS OF OBTAINING ANY CONTRACT WITH THE STATE;
- (5) CONFLICT OF CONTRACT PROVISIONS WITH CONSTITUTIONAL OR STATUTORY PROVISIONS OF STATE OR FEDERAL LAW;
- (6) ANY OTHER BREACH OF CONTRACT.

FURTHER, LSUHSC MAY TERMINATE THIS CONTRACT FOR CAUSE BASED UPON THE FAILURE OF THE CONTRACTOR TO COMPLY WITH THE TERMS AND/OR CONDITIONS OF THE CONTRACT; PROVIDED THAT LSUHSC SHALL GIVE THE CONTRACTOR WRITTEN NOTICE SPECIFYING THE FAILURE. IF WITHIN THIRTY (30) DAYS AFTER RECEIPT OF SUCH NOTICE, THE CONTRACTOR SHALL NOT HAVE EITHER CORRECTED SUCH FAILURE OR, IN THE CASE WHICH CANNOT BE CORRECTED IN THIRTY (30) DAYS, BEGUN IN GOOD FAITH TO CORRECT SAID FAILURE AND THEREAFTER PROCEEDED DILIGENTLY TO COMPLETE SUCH CORRECTION, THEN LSUHSC MAY, AT ITS OPTION, PLACE THE CONTRACTOR IN DEFAULT AND THE CONTRACT SHALL TERMINATE ON THE DATE

THE CONTRACTOR MAY EXERCISE ANY RIGHTS AVAILABLE TO IT UNDER LOUISIANA LAW TO TERMINATE FOR CAUSE UPON THE FAILURE OF LSUHSC TO COMPLY WITH THE TERMS AND CONDITIONS OF THIS CONTRACT; PROVIDED THAT THE CONTRACTOR SHALL GIVE LSUHSC WRITTEN NOTICE SPECIFYING LSUHSC'S FAILURE AND A REASONABLE OPPORTUNITY FOR LSUHSC TO CURE THE DEFECT

**TERMINATION FOR CONVENIENCE:**

LSUHSC MAY, AT ANY TIME, TERMINATE THE CONTRACT FOR THEIR CONVENIENCE AND WITHOUT CAUSE. UPON RECEIPT OF WRITTEN NOTICE FROM LSUHSC OF SUCH TERMINATION FOR THEIR CONVENIENCE, THE CONTRACTOR SHALL: CEASE OPERATIONS AS DIRECTED BY LSUHSC IN THE NOTICE; TAKE ACTIONS NECESSARY, OR THAT LSUHSC MAY DIRECT, FOR THE PROTECTION AND PRESERVATION OF THE WORK; AND EXCEPT FOR WORK DIRECTED TO BE PERFORMED PRIOR TO THE EFFECTIVE DATE OF TERMINATION STATED IN THE NOTICE, TERMINATE ALL EXISTING SUBCONTRACTS AND PURCHASE ORDERS AND ENTER INTO NO FURTHER SUBCONTRACTS AND PURCHASE ORDERS. IN CASE OF SUCH TERMINATION FOR LSUHSC'S CONVENIENCE, THE CONTRACTOR SHALL BE ENTITLED TO RECEIVE PAYMENT FOR WORK EXECUTED. LSUHSC SHALL NOT BE RESPONSIBLE OR OTHERWISE LIABLE FOR ANY DEMOBILIZATION COSTS OR INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM SUCH TERMINATION.

**TERMINATION FOR NON-APPROPRIATION OF FUNDS:**

THE CONTINUATION OF THIS CONTRACT IS CONTINGENT UPON THE APPROPRIATION OF FUNDS TO FULFILL THE REQUIREMENTS OF THE CONTRACT.

**21. DEFAULT OF CONTRACT:**

FAILURE TO DELIVER WITHIN THE TIME SPECIFIED IN THE BID WILL CONSTITUTE A DEFAULT AND MAY CAUSE CANCELLATION OF THE CONTRACT. Bidders are to include **THREE (3) CDs (or Flash drives)**, two of which will remain in the Purchasing Department, another to be referenced by the staff in the storeroom. Item prices should include all shipping, handling, insurance, and any and all other associated costs. Any additional discount packages to the offered straight pricing must be clearly shown and conditions clearly stated. All prices are to be firm for the period of the price agreement.

**No specific items are listed on this bid, overall catalog or price book discount structure is requested. The list price must be established from a verifiable source, such as a Catalog or Price List price book**

**Submission of any additional Terms and Conditions or Exceptions to the bid may cause your bid to be considered non responsive.**

Bidders must fill out the submittal page (Page 4 of the Attachment A), complete and sign the signature page (including listing vendor name and address).

Please review the invitation to bid document as changes were made to the format and content, pay special attention to page 2 , “standard terms & conditions”, number 9 “signature authority”. One of the selections should be circled and documentation provided with the bid submittal.



**PERIOD OF AGREEMENT AND RENEWAL OPTION:**

The period of the Price Agreement shall be for six months from the date of award. The contract may be extended up to nine (9) additional six month periods with the total term of the contract not to exceed sixty (60) months if agreeable with successful vendor and LSUHSC.

**SHIPMENT TERMS:**

Shipments are to be on the basis of FOB destination. Suppliers are expected to rush orders in at no additional cost when necessary to speed delivery time of orders which are delayed due to some error on the part of the supplier such as back orders due to low stock levels, incorrect shipments, delays in processing orders, et cetera. In some cases, the Scientific Supply Center staff will request 'Rush' shipments for reasons other than an error on the part of the supplier; in these cases, the supplier will have the option of adding shipping charges on a "pre-pay and add" basis. Collect shipments will not be accepted.

If supplier is not offering FOB destination, bid document must clearly state shipping terms and conditions. **If bidder does not enter specific freight terms on the submittal page, it will be assumed that freight is included in price and will ship F.O.B. destination and all freight charges will be included in the bid or quote price.**

**EQUIPMENT VERIFICATION:**

LSUHSC Scientific Supply Center research distribution outlet also purchases, on request, non-stock laboratory apparatus and equipment. Each vendor with a Net Price agreement will receive, via email, a "Current Pricing Request" indicating the item to be purchased. Vendors must respond indicating current pricing, which shall be verified against their bid to insure that the discount applied is consistent with their submission. Failure to respond to a "Current Pricing Request" means that the vendor with a net price agreement does not have equipment to offer that is equivalent to that being priced at that particular time. **CONTRACT CANCELLATION:**

LSUHSC has the right to cancel any contract for cause, in accordance with purchasing rules and regulations, including but not limited to: (1) failure to deliver within the time specified in the contract; (2) Failure of the product or service to meet specifications, conform to sample quality or to be delivered in good condition; (3) misrepresentation by the vendor; (4) fraud, collusion, conspiracy or other unlawful means of obtaining any contract with the University; (5) conflict of contract provisions with constitutional or statutory provisions of state or federal law; (6) any other breach of contract.

LSUHSC reserves the right to cancel any contract for convenience at any time by giving thirty (30) days written notice to the vendor. In such cases, the vendor shall be entitled to payment for compliant deliverables in progress.
