The warranty and maintenance shall include parts and labor and shall be available twenty-four (24) hours a day, seven (7) days per week, inclusive of state holidays, with a maximum of a four (4) hour response time, inclusive of travel time for remedial maintenance.”**

**Page 8, Section 2.12 Equipment Warranty, revised to read: “The State requires that equipment purchased through this ITB be certified eligible for Original Equipment Manufacturer (OEM) maintenance and be warrantied for a period of one (1) year. The warranty shall include parts and labor and shall be available twenty-four (24) hours a day, seven (7) days per week, inclusive of state holidays, with a maximum of a four (4) hour response time, inclusive of travel time for remedial maintenance.”**
