## CLEAN AND CAULK EXTERIOR WALLS

### Section 1.0 – Pre-Bid Conference:

A MANDATORY Pre-Bid Conference will be held:

**Location:** 100 Dolhonde Street, Gretna, LA 70053

**Date:** March 28, 2023

**Time:** 9:30 AM

All bidders must attend the **Mandatory** pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the Mandatory pre-bid conference and remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.

### Section 2.0 – Scope:

We extend this proposal to cover all labor, materials, delivery, equipment, and all other incidentals necessary to clean and seal the exterior pre-cast walls and remove and re-caulk all expansion joints on the North and West wing of the Jefferson Parish Correctional Center located at 100 Dolhonde Street, Gretna, LA. 70053.

### Section 3.0 –License Requirements:

A Louisiana State Contractor’s License will be required in accordance with LSA R.S. 37-2150 et. seq., and such license number will be shown on the outside of the bid electronic envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected”. A copy of the license is not required by law; however, they are required to specify their license number on their bid envelope.

#### 3.1 License(s) issued by the Louisiana State Licensing Board for Contractors:

### Section 4.0 –Bonds:

- **Surety Bond:** An Electronic bid bond will be required with bid submission in the amount of 5% of the total bid. The vendor shall indicate the electronic bid bond number in the location specified on the electronic bid envelope. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.
- **Performance Bond:** A Performance Bond in the amount of 100% of the total contract price will be required. The performance bond shall be produced upon contract execution.

**Section 5.0 – Quantities/Inspections:**

Bidders must inspect the site and perform their measurements to determine the proper labor, materials, and equipment required to complete this project.

**Section 6.0 – Submittals:**

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with the bid submission. Provide the requested information with your bid to ensure the bid is deemed responsive.

**7.1 Cleaning exterior of the building:**

- Pressure wash all exterior walls on the complex's North and West Wing areas. Pressure washing shall remove all loose materials, dirt, foreign materials, etc., to prepare the area for sealing and caulking. Pressure washing shall not damage any existing building materials.

**7.2 Caulking Preparation:**

- Remove existing caulking and polyethylene closed-cell foam (backer rod) from all joints
- Remove all loose materials and foreign matter that will impair the adhesion of caulking.
- All joints shall be cleaned and primed per all manufacturer recommendations and guidelines.
- Calk all parapet roof caps and joints.

**7.3 Installation of caulking:**

- Supply and install new properly sized polyethylene closed cell foam (backer rod) in removed caulking locations.
- Apply MasterSeal® P 173™ primer to all caulk joints
- Supply and install new MAsterSeal®NP 150™ sealant in all joints.
- Caulking shall be installed as per all manufacturer recommendations and guidelines.
- Caulking joints shall have a smooth finish.

**7.4 Sealing of building:**

- Exterior of all walls shall be sealed with MasterProtect® H440 VT™ silane penetrating water-repellent sealer.
- Sealer shall be applied per all manufacturer recommendations and guidelines.

Safety precautions must be exercised at all times to safeguard the welfare and safety of the building employees and the public while performing any work.

**Section 11.0 – Existing Structure**

Suppose the successful bidder should damage or destroy any part of a building, etc. In that case, the successful bidder shall be required to replace and restore said item to its original condition with the same type of material, finish, and workmanship at no additional cost to the owner. **This includes any security fence and razor ribbon that has to be moved or removed.**

**Section 12.0 – Warranty:**

**12.1 Workmanship warranty:**

- Minimum one (1) year labor warranty from the successful bidder.

**12.2 Product Warranty:**

- MAsterSeal®NP 150™ sealant minimum five (5) year material warranty from the manufacturer.

A copy of all warranties shall be provided to the owner at the completion of the project. All warranties shall commence at the completion of the project.

**Section 13.0 – Liquidated Damages:**

Commencing on the thirty-first day following the notice to proceed until work is substantially complete, liquidated damages will be assessed in the amount of \$300/day.


**Section 14.0 – Start of Work Conference and Notice to Proceed:**

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.

Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

Bidders should submit all questions in writing via email to the buyer's email address as indicated above, no later than Five (5) working days prior to the bid opening. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. B. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality.
