The following additions/changes are being made to the solicitation:

Page 8 & 9, Section 1.6 (CHANGE):

This addendum will serve as notice that the non-mandatory **Pre-Submittal Meeting/Call** has been rescheduled from 1p.m. CT, Tuesday, November 14, 2023, to **1p.m. CT, Thursday, November 16, 2023**. Physical location and virtual link remain the same.

Page 4, Section 1.2 Background (ADD CLARIFICATIONS):

There is currently a separate contract underway to assess the physical conditions of the existing 100-year-old historic club house which includes the BRG; the City Golf Course Pro-shop; and the unused former pool bath house on the lower level.

The scope of the project will not only be to design of a new contemporary arts center; but include the necessary improvements to the exiting club house based on the current assessment mentioned above.

Site evaluation of existing opportunities and constraints, and consideration of the preservation of park space, historic golf course, honoring the existing historic building's architecture, parking and sensitivity to the site and surrounding viewsheds are some of the considerations the selected team will be challenged with in order to site the building and have a concept footprint.

Page 5, Section 1.4 – Project Goals and Objectives (ADD):

Anticipated Funding will be through State Capital Outlay and other outside funding sources. Based on funding, the design and construction may need a Phased approach. The architect's fee will be calculated as a percentage of the actual construction cost per the Owner/Architect Contract. The total anticipated budget is roughly between \$12,000,000 and \$20,000,000. The building will likely be multi-story and will have a physical conditioned connection to the existing Gallery space.




APPENDIX PROPOSED BUILDING LOCATION








1927 ORIGINAL BUILDING PLANS
