Revised Statutes of 1950 to prevent the total appropriation for the year from exceeding revenues for that year, or for any other lawful purpose, and the effect of such reductions is to provide insufficient monies for the continuation of the contract, the contract shall terminate on the date of the beginning of the first Fiscal Year for which funds are not appropriated.

The Department of Transportation and Development reserves the right to cancel any or all item(s) on this contract with thirty (30) days written notice.

The Department reserves the right to terminate this contract prior to the end of the contract period upon giving
