Your reference is directed to **Contract Number**: <u>2023-SWB-97</u> (Contract 1420) for WPC Phase 1 Equipment Installation which is scheduled to open at <u>11:30 a.m.</u> **CST** on <u>March 1. 2024</u> for SWBNO Civil Engineering Department.

This addendum provides for the following:

1. Revisions

Revise scope of work associated with the electrical raceway in the WPCAUX / BOP area of the WPC site. Electrical manholes are no longer provided **by others**, and ductbanks **by others** are reduced in the WPCAUX / BOP area. Ductbank conduit from outside the WPCAUX area will be extended into the WPCAUX / BOP area **by others** and stub up in approximately the same location as the WPCAUS / BOP area manholes that have been removed. WPCAUX / BOP area electrical raceway previously routed in ductbank will largely be replaced by above grade raceway between the concrete pile cap and the bottom of the platform and equipment.

- a. The following quantities of aboveground raceway shall be ADDED to the 1420 scope of work.
 - 36-inch x 7" x C20 ladder rung cable tray: 600-feet
 - 4-inch diameter rigid metallic conduit: 1,800-feet
 - 6-inch diameter rigid metallic conduit: 1,200-feet
- b. This revision affects sheets in Volume 3 of the bid documents including but not limited to the following, which will be updated in the Conformed Documents:
 - 1416-WPCYRD-E-T-E06_-10-50
 - 1416-WPCYRD-E-T-F06_-10-50
 - 1416-WPCYRD-E-U-E06_-10-50
 - 1416-WPCYRD-E-U-F06_-10-50
 - 1420-WPCYRD-E-T-E06_-10-50

2. Responses to Questions.

a. There is no unit price Mobilization bid item that we normally see on jobs this size for costs like temporary trailers, scheduler costs, management costs, QA/QC costs, etc. Can this unit price be added, or if not, which current unit price do we use for all these indirect costs?

Include Mobilization costs in Bid Form Item 1. Following award, successful bidder will break-out and itemize these costs for use in the Schedule of Values.

The above revisions shall be incorporated in and take precedence over any conflicting part of the original proposal documents. This addendum is hereby officially made a part of the referenced proposal.

Receipt of this addendum shall be acknowledged by inserting its number and date in the space provided in the Form of Proposal.
