This solicitation is to establish a Blanket Order Contract to provide Inmate Personal Property (Shirts) as specified for the Louisiana Department of Corrections - Prison Enterprises for an initial one (1) year period beginning January 1, 2024 or date of award, whichever is later, and ending December 31, 2024. At the option of the State of Louisiana and acceptance by the Contractor, this contract may be renewed for two (2) additional twelve (12) month periods at the same prices, terms and conditions. Total contract time not to exceed thirty-six (36) months.

Blanket Order Contract:

Items are to be called for by the using agency as needed. No shipments are to be made until the Agency calls or otherwise submits an order for shipment of a specific quantity. Quantities are estimated, and they may be increased or decreased as needed throughout the contract period. Individual order quantities, when called for, are based on the using agency's demand at the time of order. Minimum orders may be one (1) unit, unless otherwise stated. THE STATE RESERVES THE RIGHT TO REJECT THE RESPONSE OF THE BIDDER OR PROPOSER IF THIS CERTIFICATION IS SUBSEQUENTLY DETERMINED TO BE FALSE, AND TO TERMINATE ANY CONTRACT AWARDED BASED ON SUCH A FALSE RESPONSE.

34. CERTIFICATION OF NO FEDERAL SUSPENSION OR DEBARMENT
