Request for Proposals:

The City of New Orleans ("City"), by and through the New Orleans Aviation Board ("NOAB"), is requesting proposals from persons, firms, and teams of firms ("Proposers") to provide shared tenant services to the NOAB which will be subject to periodic review of satisfactory performance, negotiation of terms (including price) and the availability of funds for the Louis Armstrong New Orleans International Airport. As provided below, and incident to City Charter Section 6-308(5) and Executive Order LC 20-01, it requests proposals from experienced firms to provide the needed services.

It is imperative that all Proposers read, review, and understand this RFP and all attachments. Attention should be directed to **Attachment "B" – Professional Services Agreement**. Specific terms and conditions of the Agreement to be awarded under this RFP are contained herein.

Needed Services:

The selected Proposer will be required to perform all services as set forth in Attachment "A" - Scope of Services.

Minimum Qualifications:

Proposers must meet the following minimum requirements:

- Proposer and team should have a minimum of five (5) years of IT System Support experience similar to the scope of work outlined in this procurement document.
- Proposer and team should have experience working for at least two (2) commercial services airports in the last five (5) years.
