**Section 1.0 – Site Visit:**

**Section 2.0 - Scope:**

We extend this proposal to provide labor, materials, delivery, equipment and all other incidentals necessary to provide a three (3) year contract to perform required annual tests for the following items at various Jefferson Parish Buildings, for the Department of General Services:

- Electric fire pump test
- Stand pipe test
- Fire sprinkler system inspection

**Section 3.0 – License:**

**3.1 Louisiana State Contractor’s License:**

A Louisiana State Contractor’s License will be required by LSA R.S. 37-2150 et. seq., and such license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected.

**Section 4.0 - Surety Bond:**

**Section 7.0 – Bid Specifications:**

**A.) ELECTRIC FIRE PUMP TESTS and STAND PIPE TESTS ONLY**

The following shall be performed at each location FOR every test:

- Test shall be performed once annually per building listed in these specifications.
- Inspect motor for proper alignment.
- Align motor as needed.
- Inspect pump for proper alignment.
- Align pump as needed.
- Inspect the operation of the casing relief valve on the main fire pump and jockey pump.
- Inspect pressure relief valve on the main fire pump and jockey pump.
- Replace pump packing.
- Inspect motor bearing. Grease as needed.
- Inspect pump bearing. Grease as needed.
- Inspect the operation and settings of the jockey pump. Operation and settings shall be as per the building design criteria.
- Inspect pressure setting on pump and adjust as needed. Operation and settings shall be as per the building design criteria.
- Record suction, discharge, and net pressures for at least five (5) different flow rates. 20, 40, 60, and 80 percent flow rate.
- Record voltage and amperage readings at each flow rate.
- Flow water through the roof stand pipe to verify that the required design flow rate per system is achieved. Flow rate shall be based on original building design criteria.
- Within five (5) business days of each test the successful bidder shall provide the following to the requesting department:
  1. A list of all deficiencies found on each system and a cost to repair each item.
  2. A record of all readings taken during the pump test with a graph chart showing the performance curve
  3. A detailed list identifying all deficiencies found at the time of the inspection
  4. A report listing all necessary improvements and repairs to maintain the system at or above code requirements.
- Provide a second inspection at no cost for any system deficiencies found after repairs have been performed.
- Once the final inspection is performed (If Applicable-After deficiencies have been completed) the successful bidder shall green tag the system.

**Section 7.0 – Bid Specifications Continued:**

**B.) FIRE SPRINKLER INSPECTIONS ONLY**

The following shall be performed at each location FOR every test:

- Test shall be performed once annually per building listed in these specifications.
- Perform a visual inspection of the sprinkler riser. Verify all valves, gauges, and related components are in proper position and in proper working order. A physical walk-through of the entire facility shall be conducted to ensure fire sprinkler coverage and existing application conform to NFPA 13-Standard for the Installation of Sprinkler Systems.
- Test available water supply for proper water pressure as per NFPA 72 National Fire Alarm and Signaling Code® guidelines.
- Flow water from the inspector's test to ensure flow switches activate alarm.
- Test all alarm devices for proper operation which are part of the fire sprinkler system, (i.e.,-tamper switches, pressure switches, pre-action systems, etc.).
- If applicable:
  - Check the operation of the water gong.
  - Clean external and internal obstructions.
  - Lubricate and adjust the timing for proper operation.
- Perform a drain test.
- Provide a typed report to owner within three (3) business days of each test detailing all deficiencies identified at the time of the inspection, report shall include a list of necessary improvements and repairs to maintain the system at or above code requirements.
- Provide a second inspection at no cost for any system deficiencies found after repairs have been performed.
- Test all pre-action systems. Test will include, but are not limited to all devices, panels, and releasing valves, etc. The system shall meet all NFPA guidelines for testing and servicing of pre-action systems.

**Section 8.0 – Invoicing:**

The Successful bidder shall submit an individual invoice for each location serviced under this contract to the requesting department. Department contact name, office phone numbers, and address will be provided at the issuance of the "Notice to Proceed".


**Section 9.0 – Start of Work Conference and Notice to Proceed:**

All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, all of which are made part of this bid proposal reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 136353 and/or Resolution No. 141125 as amended.

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.

All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. All quotations shall be based on F.O.B. Agency warehouse or job site, anywhere within the Parish as designated by the Purchasing Department. This provision does not apply to public works projects

JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

Bidders should submit all questions in writing via email to the Purchasing Specialist's email address as indicated above, no later than Five (5) working days prior to the bid opening. Bid numbers should be mentioned in all requests. If submitting online, vendors may send questions via the E-Procurement site no later than Five (5) working days prior to the bid opening.

If this bid requires a pre-bid conference (see Additional Requirements section), bidders are advised that such conference will be held to allow bidders the opportunity to identify any discrepancies in the bid specifications and seek further clarification regarding instructions. A. AWARD OF CONTRACT: JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)

PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA – R.S. 38:2251-2261"

B. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.

C. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at anytime and for any reason by issuing a THIRTY (30) day written notice to the contractor.

For good cause and as consideration for executing a contract with Jefferson Parish, vendor conveys, sells, assigns and transfers to Jefferson Parish or its assigns all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of Louisiana, relating to the particular good or services purchased or acquired by Jefferson Parish.

D. PRICES: Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

---

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

### **JEFFERSON PARISH REQUIRED STANDARD INSURANCE**

#### **WORKER'S COMPENSATION INSURANCE**

As required by Louisiana State Statute, exception; Employer's Liability, Section B shall be \$1,000,000 per occurrence when Work is to be over water and involves maritime exposures to cover all employees not covered under the State Worker's Compensation Act, otherwise this limit shall be no less than \$500,000 per occurrence.

**Note: If your company is not required by law to carry workmen's compensation insurance, i.e. not a Louisiana company, sole employee of the company, then bidders must request a workmen's compensation insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being**

rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

**COMMERCIAL GENERAL LIABILITY**

Shall provide limits not less than the following: \$1,000,000.00 Combined Single Limit per Occurrence for bodily injury and property damage.

**COMPREHENSIVE AUTOMOBILE LIABILITY**

Bodily injury liability \$1,000,000.00 each person; \$1,000,000.00 each occurrence.  
Property Damage Liability \$1,000,000.00 each occurrence.

**Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy of the completed, signed and properly notarized affidavit may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.**

**DEDUCTIBLES** - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

**UMBRELLA LIABILITY COVERAGE**

An umbrella policy or excess may be used to meet minimum requirements.

**FOR CONSTRUCTION AND RENOVATION PROJECTS:**

The following are required if selected below. Such insurance is due upon contract execution.

**OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

**BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
